Borough of Ship Bottom Regular Meeting Minutes May 28, 2013

The following are the minutes of the regular meeting of the Mayor and Council of the Borough of Ship Bottom, which was held on Tuesday, May 28, 2013, in the Municipal Building Council room, located at 1621 Long Beach Blvd., Ship Bottom, NJ.

Mayor Huelsenbeck called the Caucus Meeting to order at 6:34 p.m. and asked the Clerk to take attendance. The following were present:

Councilmen English, Sinopoli, Gleason, Rossi, Hartman and Tallon.

Mayor Huelsenbeck asked the Clerk to read the Statement of Notice. It is as follows:

Roll Call: English, Sinopoli, Gleason, Rossi, Hartman and Tallon, all aye.

Mayor Huelsenbeck called for the Public Hearing regarding the subdivision and diversion of a portion of parkland, Block 57, Lots 1, 2 & 3. This is in compliance with the Department of Environmental Protection, Green Acres Division, since Block 57, lots 2 & 3, that are borough owned, were purchased using Green Acres financing.

Christopher Connors, Esq., explained the purpose of the public hearing and the reason for swapping land of equal square footage. This will give the borough the piece of beachfront land for the beach replenishment project. Once the subdivision takes place, the borough can execute a "Deed of Dedication and Perpetual Storm Damage Reduction Easement", for the beach replenishment project. This will give the property owner land of equal value, to be used for his personal use. The hearing was opened to the public.

Linda Rice, 133 E. 18th St., Block 57, Lot 27, asked what each parcel of land would be used for. It was explained that the homeowner would use his piece of land for personal use and the borough would use their piece for the beach replenishment project. Ms. Rice asked the square footage and value of each piece. It was answered that it was 2561 square feet. Each piece of property had equal value to the other.

Rick McDonough, 265 W. 13th St., asked for an explanation of "park". Christopher Connors stated that it is open space. Mr. McDonough stated that the homeowner is already using the property, according to the aerial photo that he is looking at and would this be resolved after the land swap. The answer was yes.

The hearing was closed to the public. There was a transcript of these proceedings done by Darlene Sillitoe, CCR, to be submitted to NJDEP Green Acres division.

Mayor Huelsenbeck called for Resolution 2013-69: "Choose Your Cover". On a motion by Councilman Rossi, seconded by Councilman Sinopoli, this was approved as follows:

RESOLUTION 2013-69 RESOLUTION OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, IN SUPPORT OF CHOOSE YOUR COVER

WHEREAS, the OCEAN MONMOUTH HEALTH ALLIANCE Cancer Coalition is committed to educating the public about sun safety and the importance of detecting skin cancer early, volunteers will hold Choose Your Cover 2013 on July 13, 2013, at 20th Street's Beach End in Ship Bottom, Long Beach Island..

WHEREAS, skin cancer is the most common form of cancer, it is the most preventable form of cancer and the easiest to detect early and treat successfully. There are three types of skin cancer: the common basal cell and squamous cell cancers and the less common but far more serious type called melanoma. The occurrence of nonmelanoma skin cancers varies with exposure to ultraviolet light from the sun (and "sun lamps"), and indirectly with skin pigmentation.

WHEREAS, Ocean County residents and visitors can have fun outdoors while protecting their skin from the sun by choosing five sun protection options: seeking shade, covering-up, donning a hat, wearing sunglasses, and applying sunscreen. Prudent avoidance of too much sunlight is fully compatible with the enjoyment of the Township's beaches and other outdoor venues.

WHEREAS, the efforts of the OCEAN MONMOUTH HEALTH ALLIANCE Cancer Coalition through the Choose Your Cover initiative have been recognized by the Centers for Disease Control for saving lives, one beach and outdoor venue at a time because of its efforts at early detection of the dangerous melanoma and other forms of skin cancer.

WHEREAS, Ocean County is one of 21 county-wide coalitions created to help implement the New Jersey comprehensive cancer control plan based upon local needs and priorities, beachgoers and outdoor enthusiasts statewide will benefit from their participation in NJ's largest free-standing skin cancer screening on July 13th, 2013.

WHEREAS, the OCEAN MONMOUTH HEALTH ALLIANCE Cancer CoalitioN agrees that it is in the best interest of the citizens of Long Beach Island that July 13th be declared "Choose Your Cover Day" in the Borough of Ship Bottom; and

WHEREAS, the Borough of Ship Bottom Town Council joins in supporting this initiative to raise awareness about sun safety and the early detection of skin cancer

NOW, THEREFORE BE IT RESOLVED that the Governing Body of the Borough of Ship Bottom does hereby congratulate the OCEAN MONMOUTH HEALTH ALLIANCE Cancer Coalition for their outstanding leadership and proclaim July 13th as "Choose Your Cover Day" in the Borough of Ship Bottom.

WHEREAS, it is the desire of the Borough Council to authorize the execution of a Shared Services Agreement with the Borough of Beach Haven to receive temporary Construction Code Official Services in the absence of the Ship Bottom Construction Code Official for a period of three (3) years, effective January 1, 2013 and expiring December 31, 2015; and

WHEREAS, it is also the desire of the Borough Council to authorize the Borough of Ship Bottom to receive Construction Code Official Services for builders in the Borough of Ship Bottom who have a conflict of interest which disqualifies the Borough of Ship Bottom from issuing building permits and inspecting other construction in the Borough of Ship Bottom pursuant to N.J. RESOLUTION 2013-89 RESOLUTION OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TEMPORARY RELOCATION OF STRUCTURES LOCATED IN THE BOROUGH OF SHIP BOTTOM INTO THE PUBLIC RIGHT OF WAY

WHEREAS, the governing body is aware of the fact that many structures in the Borough of Ship Bottom are located on lots which have insufficient size to permit the property owner/contractor to raise the structure and to temporarily relocate the structure to another site on the owner's lot; and

WHEREAS, in order to raise these structures it is necessary to temporarily relocate the structure into the public right of way so that the existing foundation may be removed and piling may be driven to replace foundation walls.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

- 1. Property owners in the Borough of Ship Bottom may, pursuant to the following regulations, be issued a building permit granting the relocation of their structure to the public right of way following the herein below requirements:
 - a. A formal application for a building permit shall be made to the Construction Inspection Department of the Borough of Ship Bottom at least ten (10) business days prior to the contractor desiring to commence work to relocate the structure.
 - b. The application for a building permit must be contained on a form provided by the Borough of Ship Bottom Construction Inspection Department.
 - c. If the house is to be placed on an easement rather than the public right of way (a public street) it must be accompanied by a signed approval by all of the owners having rights to sue the easement.
 - d. Any issued building permit shall provide that the permitee will have a maximum use of the roadway for the relocation of the structure for no more than seven (7) business days weather permitting.

- e. Any issued building permit shall provide that the structure may not encroach on the center line of the roadway in order that traffic may safely circumvent the structure relocated in the public right of way.
- f. Any issued building permit shall be valid for work to be done only between 7:00 a.m. to 6:00 p.m. weekdays and Saturdays 7:00 a.m. through 6:00 p.m. No permit shall be effective and no work shall be permitted between 4:00 p.m. May 20th and 9:00 a.m. of the following September 15th. All times shall be local time prevailing.
- g. Any issued building permit shall stipulate that the contractor must provide uniform traffic control and appropriate traffic control devices as may be required by the Ship Bottom Borough Police Department.
- h. Building permits shall be issued only to the applicant and/or property owner pursuant to the regulations of the Borough of Ship Bottom.
- 2. Ship Bottom Borough property owners wishing to raise structures shall provide each of the following to the Construction Inspection Department at the time the application for a building permit is submitted:
 - 1. <u>Bond</u>: in the amount of \$5000 to insure the street is restored to its former condition after the house has been returned to its original location.
 - 2. <u>Photos</u>: of the area where the structure is to be temporarily re-located, prior to its placement.
 - 3. <u>Ship Bottom Borough Police Dept</u>.: Approval letter from the traffic safety officer.
 - 4. <u>Fire Co.:</u> A letter from the Volunteer Fire Co. stating they have no objection to the temporary relocation.
 - 5. <u>Insurance</u>: General Liability Certificate of Insurance for \$1,000,000.00 from the contractor naming Ship Bottom Borough as the certificate holder
 - 6. <u>Bldg. Dept.</u> Certification that gas, electric, water and sewer services have been disconnected.
 - 7. <u>Waterfront Properties:</u> Written approval of the Municipal Engineer.

BE IT FURTHER RESOLVED, that the permit procedure hereinabove described shall commence upon adoption of this Resolution.

Mayor Huelsenbeck called for Ordinance 2013-05: Second reading, public hearing and adoption, Adoption of FEMA Advisory Base Flood Elevations. On a motion by Councilman Rossi, seconded by Councilman Sinopoli and an all in favor vote, all aye, the hearing was opened to the public.

The Mayor stated that we are adopting these flawed maps because we do not want to lose points regarding our flood insurance rating and the ability for our property owners to receive their ICC (Increased Cost of Compliance) grant money from their insurance company. As corrections are made to the maps, we will readopt them.

Dorothy Jedziniak, 2511 Ocean Ave., told the Mayor that he has been warning us about the increased cost of insurance and thank you for letting everyone know.

Wade Bradley, 325 W. 17th St. and Ted Jedziniak, 2511 Ocean Ave., both had comments that needed to be in the public portion of the general meeting.

On a motion by Councilman Sinopoli, seconded by Councilman Rossi and an all in favor vote, all aye, the hearing was closed to the public.

On a motion by Councilman Sinopoli, seconded by Councilman Tallon, Ordinance 2013-05 was adopted as follows:

ORDINANCE 2013-05
ORDINANCE OF THE BOROUGH OF SHIP BOTTOM,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AMENDING AND SUPPLEMENTING CHAPTER 16.68 OF
TITLE 16 OF THE BOROUGH CODE OF THE BOROUGH
OF SHIP BOTTOM ENTITLED "FLOOD HAZARD
PREVENTION ORDINANCE" SO AS TO ADOPT THE
FEDERAL EMERGENCY MANAGEMENT AGENCY
(FEMA) ADVISORY BASE FLOOD ELEVATIONS

BE IT ORDAINED, by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

SECTION 1. Subsection 16.68.010(E) of the Borough Code of the Borough of Ship Bottom entitled "Definitions" is hereby amended and supplemented so as to repeal the definitions entitled "Areas of special flood related erosion hazard," "Flood-related erosion," "Flood-related erosion area or flood-related erosion prone area," and "Flood-related erosion area management" and to add or revise the following definitions to read as follows:

- "Advisory Base Flood Elevation (ABFE)" The elevation shown on a community's Advisory Flood Hazard Map that indicates the advisory stillwater elevation plus wave effect (ABFE=SWEL + wave effect) resulting from a flood that has a 1-percent or greater chance of being equaled or exceeded in any given year.
- "Advisory Flood Hazard Area (AFHA)" The land in the floodplain within a community subject to flooding from the 1% annual chance event depicted on the Advisory Flood Hazard Map.
- "Advisory Flood Hazard Map" The official map on which the Federal Emergency Management Administration has delineated the areas of advisory flood hazards applicable to the community.
- "Floodway" The channel of a river or other watercourse and the adjacent land areas that must be reserved in order to discharge the base flood without cumulatively increasing the water surface elevation more than 0.2 foot.
- "Substantial improvement" shall mean any reconstruction, rehabilitation, addition, or other improvement of a structure, the cost of which equals or exceeds fifty (50%) percent of the market value of the structure before the "start of construction" of the improvement. This term includes structures which have incurred "substantial damage," regardless of the actual repair work performed. The term does not, however, include either:

- 1. Any project for improvement of a structure to correct existing violations of State or local health, sanitary or safety code specifications which have been identified by the local code enforcement officer and which are the minimum necessary to assure safe living conditions; or
- 2. Any alteration of a "historic structure," provided that the alteration will not preclude the structure's continued designation as a "historic structure."

SECTION 2. Subsection 16.68.010(F)(1) of the Borough Code of the Borough of Ship Bottom entitled "Basis for Establishing the Areas of Special Flood Hazard" is hereby repealed in its entirety and replaced with the following:

- 1. Basis for Establishing the Areas of Special Flood Hazard. The areas of special flood hazard for the Borough of Ship Bottom, Community No. 340320, are identified and defined on the following documents prepared by the Federal Emergency Management Agency:
- a. A scientific and engineering report "Flood Insurance Study, Ocean County, New Jersey (all jurisdictions)" dated December 12, 2012.
- b. Flood Insurance Rate Map for Ocean County, New Jersey (all jurisdictions) as shown on Index and panels of the ABFE maps , whose effective date is December 12, 2012.
- c. Advisory Base Flood Elevations and Advisory Flood Hazard Maps dated December 12, 2012. These documents shall take precedence over previous panels and FIS in construction and development regulations only. Where the Special Flood Hazard Area (SFHA) and the Advisory Flood Hazard Area (AFHA) Maps conflict or overlap whichever imposes the more stringent requirement shall prevail.

The above documents are hereby adopted and declared to be part of this chapter. The Flood Insurance Study and maps are on file at Borough Hall, 1621 Long Beach Boulevard, Ship Bottom, New Jersey 08008.

SECTION 3. Subsection 16.68.010(I) of the Borough Code of the Borough of Ship Bottom entitled "Provision for Flood Hazard Reduction" is hereby amended and supplemented so as to revise the introductory paragraph 1 entitled "General Standards" to read as follows:

1. General Standards. For all areas of special flood hazards, compliance with the applicable requirements of the Uniform Construction Code (N.J.A.C. 5:23) and the following standards, whichever is more restrictive, is required:

SECTION 4. Subsection 16.68.01(I)(1)(c)(iv) is hereby amended and supplemented to read as follows:

- iv. For all new construction and substantial improvements the electrical, heating, ventilation, plumbing and air-conditioning equipment and other service facilities shall be designed and/or located so as to prevent water from entering or accumulating within the components during conditions of flooding.
- **SECTION 5.** Subsection 16.68.01(I)(1)(d) entitled "Subdivision Proposals" is hereby amended and supplemented to read as follows:
 - d. Subdivision Proposals.
 - i. All subdivision proposals and other proposed new development shall be consistent with the need to minimize flood damage;
 - ii. All subdivision proposals and other proposed new development shall have public utilities and facilities such as sewer, gas, electrical, and water systems located and constructed to minimize flood damage;
 - iii. All subdivision proposals and other proposed new development shall have adequate drainage provided to reduce exposure to flood damage; and
 - iv. Base flood elevation data shall be provided for subdivision proposals and other proposed new development which contain at least fifty (50) lots or five (5) acres (whichever is less).

SECTION 6. Subsection 16.68.01(I)(2) of the Borough Code of the Borough of Ship Bottom entitled "Specific Standards" is hereby deleted in its entirety and replaced with the following:

- 2. Specific Standards. In all areas of special flood hazards where base flood elevation data have been provided as set forth in subsection (F)(1), Basis for Establishing the Areas of Special Flood Hazard or in subsection (G)(3)(b) Use of Other Base Flood Data, the following standards are required:
 - a. Residential Construction.

New construction and substantial improvement of any residential structure shall have the lowest floor, including basement together with the attendant utilities and sanitary facilities, elevated at or above the base flood elevation or advisory base flood elevation whichever is more restrictive, plus one foot; Require within any AO Zone on the municipality's FIRM that all new construction and substantial improvement of any residential structure shall have the lowest floor, including basement, elevated above the highest adjacent grade one foot above the depth number specified in feet (at least three

- (3') feet if no depth number is specified) or at or above the advisory base flood elevation plus one foot, whichever is more restrictive. And, require adequate drainage paths around structures on slopes to guide floodwaters around and away from proposed structures.
 - b. Nonresidential Construction.

In an area of special flood hazard, all new construction and substantial improvement of any commercial, industrial or other nonresidential structure shall have the lowest floor, including basement together with the attendant utilities and sanitary facilities either elevated to or above the base flood elevation or advisory base flood elevation whichever is more restrictive, plus one foot; and require within any AO Zone on the Municipality's DFIRM that all new construction and substantial improvement of any commercial, industrial or other nonresidential structure shall have the lowest floor, including basement, elevated above the highest adjacent grade one foot above the depth number specified in feet (at least three (3') feet if no depth number is specified) or at or above the advisory base flood elevation plus one foot whichever is more restrictive. And, require adequate drainage paths around structures on slopes to guide floodwaters around and away from proposed structures; or

- i. Be floodproofed so that below the base flood level plus one foot or advisory base flood elevation plus one foot (whichever is more restrictive) the structure is watertight with walls substantially impermeable to the passage of water;
- ii. Have structural components capable of resisting hydrostatic and hydrodynamic loads and effects of buoyancy; and,
- iii. Be certified by a registered professional engineer or architect that the design and methods of construction are in accordance with accepted standards of practice for meeting the applicable provisions of this subsection. Such certification shall be provided to the official as set forth in Subsection (G)(3)(c)(ii)
 - c. Manufactured Homes.
- i. Manufactured homes shall be anchored in accordance with subsection (I)(1)(a)(ii).
- ii. All manufactured homes to be placed or substantially improved within an area of special flood hazard shall be elevated on a permanent foundation such that the top of the lowest floor is at or above the base flood elevation or advisory base flood elevation, plus one foot (whichever is more restrictive).

SECTION 7. Subsection 16.68.01(K) of the Borough Code of the Borough of Ship Bottom entitled "Coastal High Hazard Area" is hereby amended and supplemented so as to revise the language in subsection 16.68.01(K)(2)(a) to read as follows:

a. Elevation. All new construction and substantial improvements shall be elevated on piling so that the bottom of the lowest horizontal structural member of the lowest floor (excluding the piling) is elevated to or above the base flood elevation, advisory base flood elevation or as required by the Uniform Construction Code (N.J.A.C. 5:23), whichever is more restrictive, with all space below the lowest floors supporting member open so as not to impede the flow of water, except for breakaway walls as provided for in subsection (K)(2)(d).

SECTION 8. Subsection 16.68.01(K) of the Borough Code of the Borough of Ship Bottom entitled "Coastal High Hazard Area" is hereby amended and supplemented so as to revise the language in subsection 16.68.01(K)(3) to read as follows:

3. Sand Dunes. There shall be no man-made alteration of sand dunes within Zones VE and V on the community's DFIRM which would increase potential flood damage.

SECTION 9. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 10. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid of unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

SECTION 11. This ordinance shall take effect after public reading and publication as required by law.

Roll Call: English, Sinopoli, Gleason, Rossi, Hartman and Tallon, all aye.

Mayor Huelsenbeck called for Ordinance 2013-06: Second reading, public hearing and adoption, Exceed the Municipal Budget. On a motion by Councilman Rossi, seconded by Councilman Sinopoli and an all in favor vote, all aye, the hearing was opened to the public.

Seeing no response from the public, on a motion by Councilman Sinopoli, seconded by Councilman Tallon and an all in favor vote, all aye, the hearing was closed to the public.

On a motion by Councilman Rossi, seconded by Councilman Tallon, Ordinance 2013-06 was adopted as follows:

ORDINANCE 2013-06 AN ORDINANCE OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK FOR THE YEAR 2013 (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, (N.J.S. 40A:4-45.1) et seq., provides that in the preparation of its Annual Budget, a municipality shall limit any increase in said Budget to 2.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Mayor and Council of the Borough of Ship Bottom in the County of Ocean, finds it advisable and necessary to increase it's CY 2013 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety, and welfare of the citizens; and

WHEREAS, the Mayor and Council hereby determine that a 2.0 % increase in the budget for said year, amounting to \$109,775.52 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Ship Bottom, in the County of Ocean, a majority of the full authorized membership of this Governing Body affirmatively concurring, that in the CY 2013 budget year, the final appropriations of the Borough of Ship Bottom shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$192,107.16, and that the CY 2013 municipal budget for the Borough of Ship Bottom be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Mayor Huelsenbeck called for Ordinance 2013-07: Second reading, public hearing and adoption, no smoking, ocean beach. On a motion by Councilman Sinopoli, seconded by Councilman Rossi and an all in favor vote, all aye, the hearing was opened to the public.

Dorothy Jedziniak, 2511 Ocean Ave., said that she did not feel that smoking was an issue on the 26th St. beach but felt it was good of the Mayor to address the concerns of some of the residents.

On a motion by Councilman Sinopoli, seconded by Dr. Gleason and an all in favor vote, all aye, the hearing was closed to the public.

On a motion by Councilman Sinopoli, seconded by Dr. Gleason, Ordinance 2013-07 was adopted as follows:

ORDINANCE 2013-07
ORDINANCE OF THE BOROUGH OF SHIP BOTTOM,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AMENDING AND SUPPLEMENTING CHAPTER 12.24 OF
TITLE 12 OF THE BOROUGH CODE OF THE BOROUGH

OF SHIP BOTTOM ENTITLED "SMOKING IN PLAYGROUND AND BATHING BEACH AREAS - PROHIBITION" SO AS TO ESTABLISH NO SMOKING REGULATIONS WITHIN DESIGNATED AREAS OF THE OCEAN BEACH

BE IT ORDAINED, by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 12.24.010 of the Borough Code of the Borough of Ship Bottom entitled "Findings" is hereby amended and supplemented so as to revise Paragraph D to read as follows:

D. The borough of Ship Bottom has determined that the public health of the residents and visitors of the borough of Ship Bottom will be promoted by eliminating the exposure of its citizens to airborne tobacco smoke and smoking-related refuse within the Waterfront Park Playground located at 10th Street and Shore Avenue and the playground at the Bay Bathing Beach located between 15th and 16th Streets on the bay, hereinafter called the "playground areas." The borough has further determined that the public health of the residents and visitors of the borough of Ship Bottom will be promoted by eliminating the exposure of its citizens to airborne tobacco smoke and smoking-related refuse within the bathing beach area located on the bayfront between 13th and 16th Streets hereinafter called the "bay bathing beach area," and the ocean beach area.

SECTION 2. Section 12.24.020 of the Borough Code of the Borough of Ship Bottom entitled "Purpose" is hereby amended and supplemented to read as follows:

12.24.020 Purpose.

The borough council of the borough of Ship Bottom determines that the purpose of this chapter is:

- A. To protect and promote the public health and welfare of its community by completely prohibiting smoking within the playground, bay bathing beach and ocean beach areas.
- B. To control the litter of smoke-related refuse within the playground, bay bathing beach and ocean beach areas.

SECTION 3. Section 12.24.040 of the Borough Code of the Borough of Ship Bottom entitled "Definitions" is hereby amended and supplemented so as to add the following definition:

"Ocean beach area" means the area of beach bordering the Atlantic Ocean extending the entire length of the borough of Ship Bottom from 3rd Street to 31st Street and extending eastwardly of the bulkhead line to 100 feet seaward of the mean high water line.

SECTION 4. Section 12.24.050 of the Borough Code of the Borough of Ship Bottom entitled "Smoking prohibited within the playground and bathing beach areas" is hereby deleted in its entirety and replaced with the following:

12.24.050 Smoking prohibited within the playground, bathing beach and ocean beach areas.

Smoking shall be prohibited within the playground areas of the Waterfront Park and Bay Bathing Beach as well as the Bay Bathing Beach Area which are located in the borough of Ship Bottom. Smoking shall also be prohibited between the swimming flags of designated swimming areas within the ocean beach area during the times when lifeguards are on duty.

SECTION 5. Section 12.24.060 of the Borough Code of the Borough of Ship Bottom entitled "Posting of signs" is hereby amended and supplemented so as to revise the language in Paragraph B to read as follows:

B. Conspicuous signs shall be placed at the entrances to the playground, bathing beach and ocean beach areas.

SECTION 6. Chapter 12.24 is hereby re-titled "SMOKING IN PLAYGROUND, BATHING BEACH AND OCEAN BEACH AREAS – PROHIBITION".

SECTION 7. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 8. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid of unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

SECTION 9. This ordinance shall take effect after public reading and publication as required by law.

Roll Call: English, Sinopoli, Gleason, Rossi, Hartman and Tallon, all aye.

Mayor Huelsenbeck called for Ordinance 2013-08: Second reading, public hearing and adoption, Authorizing the acceptance of property.

Christopher Connors, Esq., explained that we will be adopting an amended ordinance. The amendment will be regarding the specific owner, because this is a property with trusts and executors and the right to use the existing property line as a front yard set back on the easterly side, after the subdivision and dedication of land.

This is not a substantial amendment to the ordinance, so the governing body can adopt this ordinance as amended.

On a motion by Councilman Sinopoli, seconded by Councilman Rossi, to amend the ordinance.

Roll Call: English, Sinopoli, Gleason, Rossi, Hartman and Tallon, all aye.

On a motion by Councilman Sinopoli, seconded by Councilman English and an all in favor vote, all aye, the hearing was opened to the public.

Seeing no response from the public, on a motion by Dr. Gleason, seconded by Councilman Sinopoli and an all in favor vote, all aye, the hearing was closed to the public.

On a motion by Councilman Tallon, seconded by Councilman Sinopoli, Ordinance 2013-08 was adopted as amended as follows:

ORDINANCE 2013-08 ORDINANCE OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE ACQUISITION OF A PORTION OF BLOCK 131, LOT 4 IN ACCORDANCE WITH N.J.S.A. 40A:12-5

WHEREAS, N.J.S.A. 40A:12-5 provides that any municipality, by ordinance, may provide for the acquisition of any real property by purchase or gift subject to lawful conditions, restrictions, or limitations as to its use by the municipality, providing the governing body accepts such lawful conditions, restrictions, or limitations; and

WHEREAS, Elizabeth H. Mershon, individually, and Elizabeth H. Mershon, Executrix of the Estate of Randolph E. Mershon or the heirs, successors and assigns of Elizabeth H. Mershon and/or the Estate of Randolph E. Mershon (hereinafter referred to as "owners") are the owners of Block 131, Lot 4 as shown on the Tax Map of the Borough of Ship Bottom (hereinafter "Borough), commonly referred to as 136 East Third Street, Ship Bottom, New Jersey (hereinafter referred to as "property") as tenants in common; and

WHEREAS, the owner(s) have offered to convey to the Borough a portion of the property as set forth on Schedule "A", a copy of which is attached hereto and made a part hereof, subject to the condition that the Deed of Conveyance for the property as set forth herein, shall reserve to the owner(s), the owner(s)' heirs, successors and assigns the right, to the extent allowed by applicable law, to include said property in the calculation of minimum square footage and front yard setback requirements when construing applications under the zoning ordinance of the Borough and that the property shall be restricted so as to prohibit the building or placement of structures on said property other than those structures necessary for the construction, preservation, repair, rehabilitation and replacement of the beach/dune system; and

WHEREAS, the conveyance of the subject property will allow the Borough to execute a Deed of Dedication and Perpetual Storm Damage Reduction Easement necessary for implementation of the Long Beach Island Storm Damage Reduction Project, which is essential in protecting the health, safety and welfare of the residents of the Borough; and

WHEREAS, the reasons as set forth herein, it is the desire of the governing body to authorize the acquisition of the subject property.

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

SECTION 1. The governing body does hereby authorize the acquisition of a portion of Block 131, Lot 4 as shown on the Tax Map of the Borough of Ship Bottom, and more particularly described in Schedule "A," a copy of which is attached hereto and made a part hereof.

SECTION 2. That the acquisition of the property described herein shall be subject to the condition that the Deed of Conveyance to the Borough shall reserve to the owner(s), the owner(s)' heirs, successors and assigns the right, to the extent allowed by applicable law, to include said property in the calculation of minimum square footage and front yard setback requirements when construing applications under the zoning ordinance of the Borough and that the property shall be restricted so as to prohibit the building or placement of structures on said property other than those structures necessary for the construction, preservation, repair and rehabilitation of the beach/dune system.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.

Revenue and Finance: David Hartman

May is coming to an end, so the tax office is preparing to send out delinquent reminders for both 2012 and 2013. For 2012, there are 39 property owners with a balance due of \$121,400.00. For 2013, there are 286 property owners with a balance due of \$391,000.00. Those delinquent for 2012 will go to tax sale this year. The date for this sale is not yet set.

In other notes: miscellaneous revenue for May, \$33,511.31, within that, standouts include: Municipal court fines & costs, \$8,544.31

Tower lease rentals of \$6,050.00 Mercantile licenses of \$4,500.00 Vendor licenses of \$4,000.00 Liquor licenses of \$2,866.00

Public Safety: Councilman Tom Tallon

The public safety report for May 2013: There were 801 reported activities. There were sixty six 911 calls. There were 6,423 patrol vehicle miles. The majority of the activity was traffic stops. There were 214 traffic stops including five DWIs. There were also 188 building and business checks.

Parks and Recreation: Councilman Edward English

We have collected \$287,290.00 in beach badge sales and \$2,490.00 at the boat ramp.

The concerts this summer will be held on Thursday nights at 7:00.

Water/Sewer: Councilman Richard Sinopoli, no report

Public Property & Community Affairs: Dr. Robert Gleason

Construction Department: 58 permits issued and 9 permit updates for a total of 67 permits. The type of work was 61 alteration/renovations, 2 addition/rehabs, 1 new building and 3 demolitions. Total revenue was \$20,758.00.

Zoning Department: 38 permits issued and 7 resale inspections.

Code Enforcement: 41 verbal warnings, 1 unleashed dog, 13 illegal signs, 25 for trash, 1 for overgrown grass and 1 for construction materials on the street. Cardboard this month, 37,748 pounds. The Barnegat Bay Blitz clean up went well, thank you to all that helped with it. We collected 72 bags of debris from the bay. The calendars for trash and recycling went out on Friday, please note the changes for off season pick up.

Buildings and Grounds, we are looking at moving back into the building until other decisions can be made.

Public Works: Councilman Peter Rossi

- 1. monthly maintenance and repairs done on all borough vehicles and equipment.
- 2. metal and brush pick up.
- 3. assisted code enforcement with cardboard at the 3rd st yard.
- 4. shoveled and swept handicap beach entrances.
- 5. continued working on fence on the ocean beach. (two men daily)
- 6. complete work on both post office and courtroom. courtroom can be used for meetings and beach badge sales.
- 7. signage repaired and put up throughout the borough. benches and trash containers put on street ends and beach.
- 8. opened life guard headquarters on 26th street.
- 9. dug a ditch at boat ramp in order for electrician to run new service. (rented ditch witch)
- 10. prepared the front of borough hall for memorial day.
- 11. grass cutting and weeding throughout the borough.
- 12. working on retaining wall at bay beach
- 13. mark outs 50 hrs.

Councilman talked about the flags that were placed at Southern Regional High School for Memorial Day. There were 6700 flags representing our soldiers that were killed in Iraq and Afghanistan.

On a motion by Councilman Sinopoli, seconded by Councilman Rossi and an all in favor vote, all aye, Mayor Huelsenbeck opened the meeting to the public.

Wade Bradley, Fire Chief, 325 W. 17th St., asked that everyone sign the easements for the beach replenishment project. He stated that if there are washouts, the fire trucks will not be able to get to the street ends.

Joe Barrett, 601 Ocean Ave., stated that the town and our beaches look great. He asked Christopher Connors about the trash that is blowing off the trucks on Route 72. Maybe

the State Police could look at this. He also stated that the dozer operator this winter was great, the spring operator, not so good.

Jon Coen, 220 W. 6th St., talked about the profile of the beaches. He does not want to be in the way of the project, but would like to be a part of the project being adjusted to create a different profile. The Mayor stated that he has a commitment from the NJDEP and the Army Corps to have a meeting regarding the engineering of the beach.

The Mayor explained that previously, Ship Bottom would have to pay a portion and was included in the planning. We are now not required to pay a share and therefore may not have as much input. The Mayor told Jon to get his best people and best information together for this meeting.

Steve Moser, 1930 Bay Terrace, said the trash collection was getting better. He asked Dr. Gleason about the new building. Dr. Gleason said we are looking at a modular/pre cast building. We are looking at getting people back in the building until we can make the best decisions financially. Mr. Moser asked what the May 15th special meeting was for. The Mayor answered that it was for a liquor license transfer.

Barbara Bishop, 1301 Ocean Ave., would like to see some of our commercial buildings cleaned up so that the town looks nicer. She suggested artwork on the plywood and the sandbags being picked up.

Dorothy Jedziniak, 2511 Ocean Ave., had attended the meeting in Stafford Township and had comments regarding the Route 72 bridge project and the projected development along the 8th & 9th St. causeway.

Scott McDonough, 265 W. 13th St., stated that the beaches look awesome. Scott said that our weekend was busy. He asked if there was any update on the business' on the 8th & 9th St. corridor, as far as fixing up the properties. He stated that the generators need to be elevated and we need to look at the fuel usage of them.

On a motion by Councilman Sinopoli, seconded by Councilman Rossi and an all in favor vote, all aye, Mayor Huelsenbeck closed the meeting to the public.

On a motion by Councilman Sinopoli, seconded by Councilman English and an all in favor vote, all aye, Mayor Huelsenbeck adjourned the meeting at 8:25 p.m..
