DISASTER CONTROL ACT, N.J.S.A. A:9-30 et. seq. AND/OR
ANY OTHER APPLICABLE PROVISION OF LAW

WHEREAS, in the furtherance of the State's recovery efforts in the aftermath of Superstorm Sandy, the Governor of the State of New Jersey issued Executive Order No. 140 on September 25, 2013. The Order directs certain actions with respect to the acquisition of real property interests for the construction of flood hazard risk reduction measures. The State of New Jersey and the Borough of Ship Bottom have concluded that they share common legal interests with respect to imminent litigation associated with obtaining property interests in the form of easements to implement flood hazard risk reduction measures pursuant to the Eminent Domain Act of 1971, *N.J.S.A.* 20:3-1 *et. seq.*; the Civilian Defense and Disaster Control Act, *N.J.S.A.* A:9-30, *et. seq.*; and/or any other applicable provision of law. The Parties anticipate that such case(s) will likely involve legal proceedings between the Parties and private property owners in the Superior Court of New Jersey, Ocean County (the "Litigation"); and

WHEREAS, the Parties have further concluded that it is in their common interest to obtain the property interests for purposes of the flood hazard risk reduction measures, and that such actions are taken to protect the public health and safety of the people of the State. To facilitate the attainment of the State and Borough's common interest, it is necessary and desirable that the parties and their respective counsel be permitted to share confidential communications and other privileged information between and among themselves; and

WHEREAS, the Parties have further concluded that they wish to continue to pursue their separate, but common, interests, without any suggestion of waiver of the confidentiality of otherwise privileged communications and documents. Since, in the absence of an Agreement, the sharing of materials and communications might be deemed to constitute a waiver of applicable privileges, it is the purpose of the agreement to ensure that the exchanges and disclosures of otherwise privileged materials and communications contemplated herein do not diminish the confidentiality of the materials and communication, and will not constitute a waiver of any otherwise applicable privilege; and

WHEREAS, it is the desire of the governing body of the Borough of Ship Bottom to authorize the execution of a Common Interest and Confidentiality Agreement.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

- 1. That the governing body does hereby authorize the execution of a Common Interest and Confidentiality Agreement with the New Jersey Department of Environmental Protection Office of Flood Hazard Risk Reduction Measures, a copy of which shall be kept on file in the Office of the Municipal Clerk and upon direction of the Office of the Attorney General shall remain confidential until such time as authorized by the Office of the Attorney General, or ordered by a Court of competent jurisdiction, to be released for public inspection.
- 2. That the Mayor and/or Borough Attorney is hereby authorized to execute any and all documents to effectuate the purpose of this resolution.
- **3.** That a certified copy of this resolution shall be annexed to the agreement and forwarded to the New Jersey Department of Environmental Protection Office of Flood Hazard Risk Reduction Measures.

Mayor Huelsenbeck called for Ordinance 2013-10: Second reading, public hearing and adoption, Zoning, Environmentally Critical District. This ordinance needed to be reintroduced and readopted, due to an advertising technicality flaw. On a motion by Councilman Rossi, seconded by Councilman Tallon and an all in favor vote, all aye, the hearing was opened to the public. Seeing no response from the public, on a motion by Councilman Rossi, seconded by Councilman English and an all in favor vote, all aye, the hearing was closed to the public. On a motion by Councilman Hartman, seconded by Councilman English, Ordinance 2013-10 was adopted as follows:

ORDINANCE 2013-10
ORDINANCE OF THE BOROUGH OF SHIP BOTTOM,

BE IT ORDAINED, by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

SECTION 1. Paragraph C of Section 16.16.010 of the Borough Code of the Borough of Ship Bottom entitled "General Requirements" is hereby amended and supplemented to revise Subparagraph 2 to read as follows:

2. Where a lot lies partially within the EC district and partially within another adjacent district, all building line setbacks and lot area calculations shall be measured from the Mean High Water Line (MHWL) so as to include upland area only.

SECTION 2. Section 16.08.020 of Chapter 16.08 of the Borough Code of the Borough of Ship Bottom entitled "Definitions" is hereby amended and supplemented to revise the following definitions to read as follows:

Coverage, Building. "Building coverage" means the aggregate square footage or other area measurement by which all buildings occupy the upland area of a lot, as measured in a horizontal plane around the periphery of the foundation, and including the area under the roof of any structure supported by columns, but not necessarily having walls, and extending more than two feet beyond the foundation. For the purposes of this title, any deck shall be included in the computation of building coverage if any part of the deck extends more than twelve (12) inches above grade level.

Coverage, Lot. "Lot coverage" means the upland (from Mean High Water Line) square footage or other area measurement by which all buildings and impervious surfaces cover a lot as measured in a horizontal plane to the limits of the impervious area(s). All parking spaces and lots, paved or unpaved, swimming pools, hot tubs, whirlpools and other bodies of collected water, buildings, roads, driveways, walkways, tennis courts, patios, and any other structure or on-site material or ground condition that does not permit the natural soil absorption and permeation of water shall be considered impervious surfaces and included in the computation of lot coverage, except that the ornamental coverage of a lot with stones or similar materials shall not be considered part of the impervious surface lot coverage if the area is clearly separate from the driveway and on-site parking areas on the lot and is not utilized at any time for the parking or movement of vehicles. For the purpose of this definition, impervious coverage shall include interlocking pavers or other pavers.

"Lot area" means the upland area contained within the lot lines of a lot, but not including any portion of a street right-of-way. Each lot shall have sufficient area within the zoning district for which development approval is requested. For the purposes of this title, no area waterward of the Mean High Water Line shall be used in computation of lot area.

"Lot depth" means the perpendicular distance between the street line or front lot line and a line drawn parallel thereto through the midpoint of the rear lot line. For the purpose of this chapter, no distance waterward from the Mean high Water Line shall be used in the computation of lot depth.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed. **SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid of unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

SECTION 5. This ordinance shall take effect after public reading and publication as required by law.

Roll Call: Gleason, Rossi, Hartman, Tallon and English, all aye. Sinopoli, absent.

Mayor Huelsenbeck called for Ordinance 2013-12: Second reading, public hearing and adoption, Eminent Domain. On a motion by Councilman Rossi, seconded by Councilman English and an all in favor vote, all aye, the hearing was opened to the public.

- 1. Dorothy Jedziniak, 2511 Ocean Ave., asked who would have the power to do the eminent domain process, the borough, state or army corps? The Mayor responded that the borough would do the surveys and appraisals and then work with the state to complete the eminent domain process.
- 2. Ted Jedziniak, 2511 Ocean Ave., had comments regarding the beach replenishment project and the eminent domain process.
- 3. Barbara Bishop, 1301 Ocean Ave., asked if the borough would treat all oceanfront properties the same, regardless of how the easement was obtained? The Mayor answered, yes.
- 4. Councilman English asked who would maintain the beaches once the project is complete. The Mayor answered, that the borough would maintain the beaches, unless there was major damage from a storm, then the Army Corps would come and repair their project.
- 5. Ted Jedziniak, 2511 Ocean Ave., asked if there was a washout between now and the end of the year, would the borough repair it. The Mayor answered that if there is a signed easement in place, the borough would push sand. If there is not an easement in place, the borough will not come on private property.
- 6. Walter Arosemowicz, 2203 Bay Terrace, asked if perpetuity regarding this project refers to putting sand on the beach whenever it is necessary and only sand. The answer was yes. Mr. Arosemowicz explained that he had bayfront property and does not expect the town to protect his land on the bay. He does not feel that the oceanfront properties are entitled to anything more that the bayfront property owners.

On a motion by Councilman Rossi, seconded by Councilman English and an all in favor vote, all aye, the hearing was closed to the public.

On a motion by Councilman Tallon, seconded by Councilman English, Ordinance 2013-12 was adopted as follows:

ORDINANCE NO. 2013-12 ORDINANCE OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE ACQUISITION OF CERTAIN INTERESTS IN REAL PROPERTIES BY NEGOTIATION, PURCHASE, CONDEMNATION OR EMINENT DOMAIN, SAID PROPERTIES BEING IDENTIFIED ON THE ANNEXED SCHEDULE AND PARCEL MAPS

WHEREAS, Superstorm Sandy caused significant and widespread damages to public and private property along the oceanfront and has greatly diminished pre-existing flood hazard risk reduction measures, making the Borough of Ship Bottom, extremely vulnerable to future storms; and WHEREAS, on October 27, 2012 the Governor issued Executive Order No. 104, wherein he declared a state of emergency because of Superstorm Sandy; and

WHEREAS, on September 25, 2013 the Governor issued Executive Order No. 140, wherein he declared that the construction of flood hazard risk reduction measures along New Jersey's coastline, including the Borough of Ship Bottom, is necessary to protect the public health, safety, and welfare from future natural disasters, and that reliance on certain statutory authority for the acquisition of property, including but not limited to N.J.S.A. 20:3-1, et seq. and N.J.S.A. App. A:9-51.5, is necessary for such efforts; and

WHEREAS, the State of New Jersey recognizes and supports public acquisition of certain interests in storm-damaged and storm-prone property as a priority hazard mitigation strategy to promote the public health, safety, and welfare; and

WHEREAS, the Mayor and Governing Body of the Borough of Ship Bottom have concluded that it is necessary, desirable, and appropriate for the Borough of Ship Bottom to undertake project for flood hazard risk reduction measures; and

WHEREAS, there is currently private ownership of certain portions of the lands where said flood hazard risk reduction measures shall be undertaken; and

WHEREAS, by adoption of this Ordinance the Borough of Ship Bottom authorizes the taking of perpetual easements in a portion of each identified privately owned property by condemnation/eminent domain so that the Borough of Ship Bottom and other entities or agents acting on behalf of the Borough of Ship Bottom shall have access onto, over, and through said privately owned real property for the purpose of taking any and all actions necessary for completing said flood hazard risk reduction measures; and

WHEREAS, the Mayor and Governing Body of the Borough of Ship Bottom further find that a public use and purpose would be served for the benefit of the Borough of Ship Bottom and surrounding communities by acquiring certain property interests in the aforesaid property, including, but not limited to, the promotion, protection, and preservation of the public health, safety, and welfare of the Borough of Ship Bottom and its inhabitants by the acquisition of certain interests in said real property for storm damage and flood area mitigation through conducting the said flood hazard risk reduction measures, to protect public infrastructure located with the Borough of Ship Bottom, to mitigate future storm damage and associated public recovery expenditures, and for the protection, preservation, and conservation of precious natural resources; and

WHEREAS, the Mayor and Governing Body of the Borough of Ship Bottom are authorized by the New Jersey State Constitution, N.J.S.A. 40A:12-5(a), N.J.S.A. 20:3-1 et seq., and/or any other provision of applicable law to proceed with acquiring certain property interests by condemnation/eminent domain as long as just compensation is paid for the same;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Governing Body of the Borough of Ship Bottom, in the County of Ocean and State of New Jersey as follows:

- 1. **RECITALS INCORPORATED**: The above recitals are incorporated into this section of the Ordinance as if specifically set forth at length herein.
- 2. SPECIFIC FINDINGS: The Mayor and Governing Body of the Borough of Ship Bottom find that the flood hazard risk reduction measures will promote and protect the health, safety, and welfare of residents of the Borough of Ship Bottom, and will prevent property damage and loss due to flooding, and further find that any purchase or taking by eminent domain of any and all property interests necessary for the same are all in the furtherance of a public use and purpose.
 - **AUTHORIZE CONDEMNATION**: The Mayor and Governing Body of the Borough of Ship Bottom specially authorize any and all necessary and appropriate actions by the Borough of Ship Bottom officials including the Mayor, Municipal Clerk, Municipal Attorney, and/or Special Condemnation Attorney, in conjunction with the Office of Flood Hazard Risk Reduction Measures within the New Jersey Department of Environmental Protection and/or any other appropriate State or Federal entity, for the taking and obtaining of certain property interests in the properties as set forth herein through negotiation, purchase, or condemnation/eminent domain, including, but not limited to, the hiring of any experts, engaging the services of land surveyors, title insurance companies, appraisers, and any other professional whose services are necessary or appropriate to implement the purposes of this Ordinance, the making of any offer by the Borough of Ship Bottom to the property owner(s) in the full amount of the appraised value of the property interest that the Municipality seeks to acquire in said property, and to negotiate in good faith with the record owner(s) of the property for its voluntary acquisition in accordance with N.J.S.A. 20:3-6, and in the event that the negotiations for the voluntary acquisition of the property interest are unsuccessful for any reason to commence a condemnation action by the filing of a Verified Complaint and Declaration of Taking, depositing the estimated just compensation with the Clerk of the Superior Court, filing a Lis Pendens, and taking any and all other actions of any administrative or other nature necessary to complete the process contemplated by this Ordinance.
- 4. <u>IDENTIFICATION OF PROPERTY</u>: The properties for which a taking of property interests is authorized by negotiation, purchase, or condemnation/eminent domain pursuant to this Ordinance are located in the Borough of Ship Bottom and listed on the Municipality tax map, the legal descriptions of which are attached as Exhibit A to this Ordinance and specifically incorporated into this Ordinance by reference. The property

interests to be acquired are irrevocable, perpetual, permanent easements in the properties identified herein.

- 5. **OFFICIALS AUTHORIZED**: All appropriate officials of the Borough of Ship Bottom, including, but not limited, to the Mayor, Municipal Clerk, Municipal Attorney, Special Condemnation Attorney, and any and all experts or others acting on behalf of the Borough of Ship Bottom are authorized by this Ordinance to sign any and all documentation and take any and all action necessary to effectuate the purposes and intention of this Ordinance.
- 6. PURCHASE OF PROPERTY: If a determination is made by a majority vote of the Governing Body of the Borough of Ship Bottom that the purchase of an easement is more appropriate than the obtaining said property interest through condemnation/eminent domain, then all appropriate officials of the Municipality, including, but not limited to, the Mayor, Municipal Clerk, Municipal Attorney, and Special Condemnation Attorney are authorized by this Ordinance to sign any and all documentation to effectuate the purchase of the property interests by the Borough of Ship Bottom.
- 7. **REPEALER**: All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.
- 8. <u>SEVERABILITY</u>: If any section, paragraph, subdivision, subsection, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause, or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.
- 9. **EFFECTIVE DATE**: This Ordinance shall take effect immediately upon final adoption and publication as required by law.

On December 11th at 10:30 am in Council Chambers, we will be holding our Tax Sale. Originally there were 34 listed properties advertised. Currently the list has gone down to 23 properties. I know this is a difficult time for everyone but it is mandatory that a tax sale be held every year. Our sale is for 2012 only but once a lien is placed on the property the lien holder can pay all delinquent taxes at an additional 18 per cent interest. Please make every effort to bring any delinquent amount current. Total taxes collected in November \$1,741,700.00. Total delinquent taxes still outstanding \$602,621.00. Total miscellaneous monies collected \$22,450.00. The ladies and a few gentlemen in the finance and tax office would like to thank Bob Rossi and crew for all their hard work to get the office up and running. It really looks great. Thank you Bob for all your hard work and long hours.

Currently we are selling Christmas gift beach badges for 2014. They make a great gift and can be purchased at the tax office window.

FEMA Reimbursements Update:

We submitted 14 different projects to FEMA and \$1,188,611.00 is 90% of what was submitted and is what we should be receiving from FEMA. So far, we have received \$247,788.00 which translates to approximately 20% of what we should recover. It is a very slow process.

We are doing a budget comparison. There are charts on the front table if anyone would like a copy.

We pumped 9,788,000 gallons for the month of October. We inspected and operated the water plant and wells. We helped with the water meter reads and repairs. All repairs were made to the water & sewer systems as needed.

Public Property and Public Affairs: Dr. Robert Gleason

Zoning Department: 19 zoning permits were issued and there were 8 resale inspections Construction Department: 46 permits and 8 permit updates processed, of that there were 41 alteration/renovations, 3 addition/rehabilitations, 3 new buildings and 8 demolitions. The total revenue was \$18,185.00.

Code Enforcement:

Animal control last month caught 2 possums and 1 raccoon. Our cardboard total is up to 128,468 pounds, the most we ever collected in town.

There were 13 verbal warnings, 7 for illegal signs, 2 for trash, 2 for trailer on street and 2 for construction materials on street.

Buildings and Grounds: the borough hall is almost finished. Everyone is back in the building and the last trailer is ready to be removed.
