Regular Meeting Minutes
June 25, 2019

The following are the minutes of the Regular Meeting of the Mayor and Council of the Borough of Ship Bottom, which was held on Tuesday, June 25, 2019, in the Borough Hall Council Chambers, located at 1621 Long Beach Boulevard, Ship Bottom, New Jersey.

Mayor Huelsenbeck called the Caucus Meeting to order at 6:00 p.m. and asked the Clerk to take attendance. The following were present:

Councilmen Butkus, Rossi, Tallon, English and Valyo. Hartman, absent.

Christopher Connors, Esq. and Tennant Magee, Esq. were also present.

Mayor Huelsenbeck asked the Clerk to read the Statement of Notice. It is as follows:

The time, date and location of this meeting was sent to the Asbury Park Press, published in the Beach Haven Times on June 20th and also posted on the bulletin board in the Municipal Building on June 17th, 2019, in accordance with the Open Public Meetings Act.

Mayor Huelsenbeck explained the need for an Executive Closed Session Meeting. On a motion by Councilman Rossi, seconded by Councilman Valyo, Resolution 2019-81 was approved as follows:

WHEREAS, the Mayor and Governing Body are in need of a Closed Executive Session to discuss legal matters.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Ship Bottom, that the Governing Body will hold a Closed Executive Session on this 25th day of June 2019.

BE IT FURTHER RESOLVED, that the matters discussed may be revealed to the public when these issues are no longer sensitive, with the approval of the Borough Solicitor.

BE IT FURTHER RESOLVED that no official action will take place in the Closed Executive Session, but official action may be taken when the meeting is again opened to the public.

Roll Call: Rossi, Tallon and Valyo, all aye. Butkus and English, abstain. Hartman, absent.

The Executive Session was in progress from 6:04 pm until 6:25 pm.

Mayor Huelsenbeck called the Regular Meeting to order at 6:28 p.m. and asked the Clerk to take attendance. The following were present:

Councilmen Butkus, Rossi, Tallon, English and Valyo. Hartman, absent.

Christopher Connors, Esq. and Tennant Magee, Esq. were also present.

Mayor Huelsenbeck asked the Clerk to read the Statement of Notice. It is as follows:

June 25, 2019

Mayor Huelsenbeck called for the approval of the minutes of the Regular Meeting held on May 28, 2019. On a motion by Councilman Tallon, seconded by Councilman Rossi, the minutes were approved.

Roll Call: Butkus, Rossi, Tallon, English and Valyo, all aye.

Councilman Hartman arrived at 6:33 pm.

Mayor Huelsenbeck called for the public hearing for the Comcast Municipal Consent.

Darlene Sillitoe, Certified Court Reporter, was in attendance for this public hearing.

Rob Clifton, Senior Director of Government & Regulatory Affairs, Comcast Cable, gave a presentation on the Application for Renewal of Municipal Consent to Construct and Operate a Cable TV System in the Borough of Ship Bottom.

On a motion by Councilman Rossi, seconded by Councilman Butkus and all in favor vote, all aye, the hearing was opened to the public.

Mayor Huelsenbeck asked about redundancy on the Island. Rob explained that the only cable coming onto the Island is at the Causeway bridges.

Councilman Butkus asked about the Comcast office closing in Ship Bottom and would there be another location opening on the Island. Rob explained that the Route 9 office in Manahawkin was expanded prior to the Ship Bottom office closing. The new store on Route 72 will be opening shortly.

Having no response from the public, on a motion by Councilman Rossi, seconded by Councilman Tallon and all in favor vote, all aye, the hearing was closed to the public.

Tennant Magee, Esq. is representing the Borough of Ship Bottom on this matter.

Councilman Valyo made a motion, seconded by Councilman Rossi, authorizing Christopher Connors, Esq., Borough Counsel, to file an appeal of the Land Use Review Board's decision regarding Wainwright Amusements, LLC.

Roll Call: Rossi, Tallon and Valyo, all aye. Butkus, Hartman and English, abstained.

Mayor Huelsenbeck called for Resolution 2019-82: Authorizing payment of municipal bills. On a motion by Councilman English, seconded by Councilman Hartman, this was approved as follows:

Mayor Huelsenbeck called for Resolution 2019-83 through Resolution 2019-90: Authorizing the renewal of liquor licenses. On a motion by Councilman Rossi, seconded by Councilman Butkus to approve these resolutions. Councilmen Butkus, Rossi and Hartman, yes. Councilmen Tallon, English and Valyo voted yes on all, except Resolution 2019-90: Hotel LBI. After Councilman Tallon's no vote and proceeding through the no votes of Councilman English and Valyo, there was discussion regarding the parking on and around the property of the Hotel LBI. Christopher Connors, explained that the conditions on the liquor licenses were relative to alcohol, not parking. I, the Clerk, read the conditions on the renewal for the Hotel LBI. Councilman English asked to be able to change his no vote to a yes. Christopher Connors said that was acceptable with a new motion, second and roll call vote.

On a motion by Councilman Rossi, seconded by Councilman Butkus to approve Resolution 2019-83 through Resolution 2019-90.

Roll Call: Butkus, Rossi, Hartman and English, all aye. Tallon and Valyo, aye on all except Resolution 2019-90 was a no vote.

I would like to include the Treasurer's Report: Bank of America, May 2019 Tax Revenue, month to date is \$176,937.38; and of that: \$174,746.46 is for 2019 and \$2,190.92 is for interest.

Our Collection percentage is 97.52%. We have 85 properties that are delinquent with their property taxes.

As soon as the state reaches their budget and the tax rate is struck, the tax office will work on getting the 2019/2020 tax bills out in the mail. An extension on the August 1st payment date will be given if needed.

Public Safety: Councilman Tom Tallon

The public safety report for June 2019. There were 825 reported activities. There were 4,633 patrol vehicle miles. There were 73 beach, building and business checks. There were also 484 traffic stops, one motor vehicle death, twenty-one motor vehicle accidents without injuries, one motor vehicle accident with injuries and two DUI's.

Parks and Recreation: Councilman Edward English

Opening day this season was Saturday, June 15.

Rookie school is being held this week. These new lifeguards will graduate on Saturday, June 29 and be ready for the 4th of July weekend.

Thanks to all Council members and Borough departments for their help in getting the beach patrol ready for another summer.

The concerts are as follows: July 11th - "Bullzeye", July 18th - "The Nerds", July 25th - "The Impulsives", August 1st - "The Kootz Band", August 8 - "Triple Rail Turn", August 15th - "Shorty Long", August 22nd - "Verdict", August 29th - "Jimmy and the Parrots".

Public Property & Community Affairs: Councilman Joseph Valyo

Construction: There were 17 permits and 6 permit updates, for a total of 23 permits processed. The type of work was 13 alteration/renovations, 2 for minor work, 4 for addition/rehabs, 1 new building, and 3 additions. The total revenue was \$8,971.00.

Zoning: there were 8 resale inspections and 30 zoning permits issued.

Water/Sewer: Councilman Robert Butkus

For the month of May, we pumped 18,561,000 gallons of water.

We received \$28,663.91 in water payments and \$39,468.51 in sewer payments for a total of \$68,132.42.

There are 54 water/sewer accounts that are in delinquent status, 4 are commercial 46 are residential non-metered and 4 are residential metered. Delinquent notices have been mailed.

Public Works: Councilman Peter Rossi

Monthly maintenance on all borough vehicles and equipment, grass cutting weeding and recyclables, metal and brush was picked up. White chairs and flags were set up at borough hall for Memorial Day service. Trash and recycle containers placed on ocean front street ends. Snow fence put up at bay beach. Paddle board ramp put in, had to repair 6X6 pole that is secured in bay that holds ramp. Repaired leaks and clogged toilets in our public rest rooms. Life-guard boxes put on beach, volleyball net put up, swept and shoveled beach entrances, painted street ends walls, repaired walkways and split rail fence as needed. Beach raking and trash picked up daily, back blading bay beach, raking shells at the boat ramp. Removed pink lights from anchor and gazebo at the boat ramp. Signs

repaired and replaced where needed. Street ends painted, no parking beyond line. Pot-holes filled throughout the borough. Repaired broken step at 20th street park.

3. Ken Reuter, 340 W. 10th St., asked the Borough Council to prohibit engine braking of the trucks. He stated that the Hotel LBI is creating parking issues on the side streets and the music can be heard on 10th St. Mr. Reuter talked in length regarding the speeding cars coming eastbound on 10th St. He filed a petition with the Clerk.
4. Ed English suggested cameras be installed in order to write tickets to speeders.
5. Carol Parelli, 346 W. 10th St., had comments regarding speeding cars on 10th St. Carol liked the idea of cameras and tickets.
6. Joe Valyo suggested marked police cars with mannequins as a deterrent.
7. Chris Connors, Esq. stated that cameras for that purpose are illegal in NJ.
8. Donna Edwards, 347 W. 10th St., stated that the Hotel LBI has created noise issues and traffic issues in the area. The playground and wooden walkway at the Waterfront Park is in disrepair. It was stated that we are in the process of fixing this.
9. Ken Reuter suggested one-side parking on 10th St.
10. Bill Fennimore, 5 Robert Drive, has concerns with the parking at the new Hotel LBI.
11. Rick McDonough, 265 W. 13th St., thanked everyone for the response to Saturday's motor vehicle accident. He stated that he is in support of Wainwrights Amusements.
12. Todd McClennon, Ship Bottom Fire Chief, stated that they have has 101 calls so far this year. He asked everyone to come out and support the Fire Co. Block Party on July 6th.

On a motion by Councilman Rossi, seconded by Councilman Tallon and all in favor vote, all aye, Mayor Huelsenbeck closed the meeting to the public.
