Regular Meeting Minutes March 24, 2015

The following are the minutes of the Regular Meeting of the Mayor and Council of the Borough of Ship Bottom, which was held on Tuesday, March 24, 2015, in the Borough Hall Council Chambers, located at 1621 Long Beach Boulevard, Ship Bottom, New Jersey.

Mayor Huelsenbeck called the Caucus Meeting to order at 6:35 p.m.

Mayor Huelsenbeck asked the Clerk to take attendance. The following were present:

Councilmen Sinopoli, Gleason, Rossi, Hartman, Tallon and English.

Mayor Huelsenbeck asked the Clerk to read the Statement of Notice. It is as follows:

The time, date and location of this meeting was advertised in the Beach Haven Times, Atlantic City Press and Asbury Park Press. It was also posted on the bulletin board in the Municipal Building, in accordance with the Open Public Meetings Act.

During the Caucus meeting, Mayor Huelsenbeck talked about the upcoming beach replenishment project. It is expected to begin in Ship Bottom between April 20th and April 30th. It will take about 35 days to complete our Borough. They will drop the pipe on 8th St. beach, pump north to 3rd St. then south to 13th St.. The pipe will be moved to 23rd St., they will pump north to 13th St., then south to 31st St. The crosswalk will be complete within 14 days after the sand. The project will progress approximately 100 ft. per day and close off 1000 ft. of beach at a time.

Councilman English talked about the need for public restrooms within the Borough.

Patrolman Snow from Harvey Cedars, spoke on behalf of David's Dream and Believe Cancer Foundation. Their request will be heard during the Correspondence portion of the meeting.

Early this month we sent out delinquency notices for both water/sewer bills and property taxes. The response has been so-so.

Taxes collected so far for the month of March -\$248,927.00, of that:

\$209,061.00 was for 2015, \$36,069.00 was for 2014, \$3,795.00 was for interest only payments.

Miscellaneous revenues collected this month so far were \$12,893.00 - notables within that were: municipal court fines and costs for \$5,278.00, tower lease rental for \$3,025.00 and land-use fees for \$1,125.00.

The public safety report for March 2015: There were 896 reported activities. There were 5,549 patrol vehicle miles. There were 326 building and business checks. There were also 251 traffic stops, and 7 motor vehicle accidents without injuries.

For the month of February, we pumped 9,731,000 gallons of water. Daily work completed: inspect and operate plant and wells and helped with water meter reads and repairs.

There were a lot of homes that had the water turned off due to broken pipes from freezing.

Public Property and Community Affairs: Dr. Robert Gleason

Construction Dept: There were 20 permits and 3 permit updates processed. The type of work was 11 alteration/renovations, 1 renovate/reconstructs, 4 addition/rehabs, 1 new building and 6 demolitions. The total revenue was \$7,217.00.

Zoning Dept.: There were 4 zoning permits issued and 16 resale inspections done.

Code Enforcement: There were 15 verbal warnings issued, majority for illegal signs, trash, trailer on street and construction materials on street.
