APPENDIX B, FOR THE PURPOSE OF REPAIR, RESTORATION, REPLACEMENT AND/OR CONSTRUCTION OF FLOOD HAZARD RISK REDUCTION MEASURES PURSUANT TO N.J.S.A. App. A:9-51.5

WHEREAS, Superstorm Sandy caused extensive damage to life and property in the municipalities along much of the Atlantic Coast of New Jersey, including the Borough of Ship Bottom (hereinafter "the Municipality"); and

WHEREAS, the damage caused to the Municipality and the State of New Jersey ("the State") by Superstorm Sandy included, among other things, damage to the Borough's Water Plant Facilities including loss of the emergency generator backup system for the 17th and 15th street water plants; washover from the Atlantic Ocean at 16th and 17th streets which caused flooding and extensive damage to the Borough's Municipal and Police Station Complex including loss of use for over a 1 year period; excessive erosion and damage to the existing dune system along the entire oceanfront; and extensive damage to the recreational facilities and parks throughout the Borough; excessive flooding and damage to the housing stock of the entire municipality which displaced the Borough's population in some instances for over a year or more; and

WHEREAS, due to the damage that the Municipality sustained as a result of Superstorm Sandy, the Municipality approved the following resolutions and ordinances:

- 1. Resolution 2012-148: Authorizing a Shared Services Agreement with Ocean County for Debris Removal, Debris Monitoring and Related Services
- 2. Resolution 2012-161: Declaration of Emergency and Provision for Appropriation of Emergency Funding For The Borough Of Ship Bottom.
- 3. Resolution 2012-162: Authorizing Various Emergency Contracts for Hurricane "Sandy" Storm-Related Goods and Services in the Borough of Ship Bottom
- 4. Resolution 2013-44: Authorizing an Amended Shared Services Agreement With Ocean County For Debris Removal, Debris Monitoring and Related Services
- 5. Ordinance 2013-12: Authorizing the acquisition of certain interests in real properties by negotiation, purchase, condemnation or eminent domain, said properties being identified on the annexed schedule and parcel maps.
- 6. Ordinance 2014-09: Authorizing the acquisition certain interests in real properties by negotiation, purchase, condemnation or eminent domain, said properties being identified on the annexed schedule and parcel maps.

WHEREAS, in response to the devastation from Superstorm Sandy, the United States Congress has appropriated funds for the creation, improvement, and reconstruction of flood hazard risk reduction measures across New Jersey's coastline, including in the Municipality; and

WHEREAS, the Municipality is in the process of a shore protection project in conjunction with the New Jersey Department of Environmental Protection ("DEP"), and/or other federal/state entities, the purpose of which is the creation, improvement, and/or reconstruction of flood hazard risk reduction measures in the Municipality for the protection of the Municipality and the property and citizens thereof; and

WHEREAS, as part of the design of these flood hazard risk reduction measures, governmental entities have identified all property interests that must be obtained for construction of the flood hazard risk reduction measures, and these required property interests include a perpetual easement the form of which is included as Appendix A to this Resolution; and

WHEREAS, some owners of the property where easements are necessary for the flood hazard risk reduction measures have voluntarily provided the needed property interests to the Municipality and/or other public entities; and

WHEREAS, other property owners where easements are necessary for the flood hazard risk reduction measures have not provided the needed property interests, and those property owners and their respective properties (collectively, the "Properties") are identified on the tax map of the Municipalityin Appendix B to this Resolution; and

WHEREAS, Superstorm Sandy has compromised, damaged and/or destroyed existing flood hazard risk reduction measures that have previously protected the Municipality from flooding caused by tidal waters; and

WHEREAS, the Municipality's governing body has decided that repairing, restoring, replacing, and/or constructing the flood hazard risk reduction measures at, upon, and/or around the Properties is necessary for the protection of the public health, safety, and welfare, as well as the protection of the Properties, the surrounding properties, the affected residences, and the subject neighborhood, and that the flood hazard risk reduction measures will allow the Municipality and the region as a whole to be more resilient and better able to withstand the next storm and its aftermath; and

WHEREAS, the Municipality has performed title work to determine the record owner(s) of the Properties, and the Municipality has made efforts to negotiate the voluntary transfer of the real property interests necessary for the flood hazard risk reduction measures, but those efforts have not been successful for the Properties listed in Appendix B; and

WHEREAS, the owner(s) of record of the Properties had last-known address(es) detailed in Appendix B; and

WHEREAS, using public funds, federal and/or state entities intend to begin construction of the flood hazard risk reduction measures in the Municipality in or about January 1, 2015; and

WHEREAS, the flood hazard risk reduction measures currently planned to be constructed in the Municipality consist of replenished beaches and engineered sand dunes; and

WHEREAS, that project cannot proceed until the Municipality provides to federal and/or state entities perpetual easement(s) in the form of Appendix A for the easement area on each of the Properties as set forth in Appendix C to this Resolution, and thus failure to provide the necessary easement(s) before the construction of the flood hazard risk reduction measures would delay, increase the cost of, and potentially frustrate the project's construction; and

WHEREAS, the potential delay and increase in cost is a matter of urgency and importance, and would result in substantial harm to the public health, safety, and welfare; and

WHEREAS, on October 27, 2012 the Governor issued Executive Order No. 104, wherein he declared a state of emergency because of Superstorm Sandy, and expressly reserved the right to utilize and employ all available resources of the State government and each and every political subdivision of the State, whether of persons, properties, or instrumentalities, and to commandeer and utilize any personal services and any privately owned property necessary to protect against the declared emergency; and

WHEREAS, on September 25, 2013 the Governor issued Executive Order No. 140, wherein he declared that the construction of flood hazard risk reduction measures along New Jersey's coastline, including in the Municipality, is necessary to protect the public health, safety, and welfare from future natural disasters, and that reliance on certain statutory authority for the acquisition of property, including but not limited to N.J.S.A. App. A:9-51.5, is necessary for such efforts; and

WHEREAS, in Executive Order No. 140, the Governor ordered that no municipality, county, or other agency or political subdivision of the State shall enact or enforce any order, rule, regulation, ordinance, or resolution, which will or might in any way conflict with the provisions of Executive Order No. 140, or which will in any way interfere with or impede its achievement; and

WHEREAS, pursuant to N.J.S.A. App. A:9-51.5, if the Municipality, which borders the Atlantic Ocean, finds that there exists a threat or danger to life and property by reason of the damage to or the destruction of sand barriers and other natural or manmade barriers which protect the Municipality, and that it is necessary to the health, safety, and welfare of the Municipality to repair, restore, replace, or construct such flood hazard risk reduction measures, then the Municipality may, by resolution, as an exercise of the police power of the State, designate properties required for the purpose of providing such protective barriers and authorize the appropriate municipal or government officials or agencies or the representatives thereof to enter upon such property within ten (10) days of the passage of such a resolution (or a shorter period of time if the Municipality finds that a shorter time is necessary for the public safety and interest) to take control and possession thereof, and to do such acts as may be required without first paying any compensation therefor; and

WHEREAS, the passage of such a resolution would enable the project for the flood hazard risk reduction measures to continue without delay in the Municipality;

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Ship Bottom, County of Ocean, New Jersey as follows:

- 1. Pursuant to N.J.S.A. App. A:9-51.5, the Municipality finds that there is a threat or danger to life and property caused by Superstorm Sandy due to the compromise of, damage to and/or destruction of flood hazard risk reduction measures that protect the Municipality; and
- 2. The portion(s) of the real propert(y/ies) identified in Appendix B (the "Properties") are hereby designated as property required for control and possession by the Municipality, its representatives and any other governmental entities or agencies, or the representatives thereof, in order to construct and maintain the flood hazard risk reduction measures for the protection of the public health, safety, and welfare, as well as the protection of the Properties, the surrounding properties, the affected residences, and the subject neighborhood, and that the flood hazard risk reduction measures will allow the Municipality and the region as a whole to be more resilient and better able to withstand the next storm and its aftermath; and
- 3. Pursuant to N.J.S.A. App. A:9-51.5, the Municipality hereby authorizes the DEP and their representatives, including any other designated state and/or federal entities, to enter the Properties within ten (10) days of the passage of this Resolution to take control and possession thereof, and permits the DEP and their representatives to do such acts as may be required to repair, restore, replace, and/or construct the flood hazard risk reduction measures as contemplated in the project for the Municipality; and
- 4. Pursuant to N.J.S.A. App. A:9-51.5, the Municipality hereby declares it has taken a perpetual and assignable easement and right-of-way for the flood hazard risk reduction measures in, on, over, and across that land of the Properties described in Appendix B in favor of itself and the State of New Jersey for purposes of construction, preservation, patrol, operation, maintenance, repair, rehabilition, and replacement of the flood hazard risk reduction measures, pursuant to the form of easement(s) attached to this Resolution as Appendix A; and
- 5. A certified copy of this Resolution certified by the Clerk of the Muicipality shall be recorded with the Ocean CountyClerk's Office and recorded in the book for deeds; and

- 6. A copy of this Resolution shall also be provided to the owners of record via certified mail, return receipt requested, and regular mail, at their last known address within two (2) business days of the date of this Resolution; and
- 7. To prevent a delay in the project and any resulting costs, entry upon and possession of the Properties may be made without first paying any compensation therefor; and
- 8. In accordance with N.J.S.A. App. A:9-51.7, the owners of the Properties retain the right to obtain just compensation, if any, for the possession of the Properties, subject to all appropriate setoffs for benefits conferred on the property by the flood hazard risk reduction measures; and
- 9. To ensure that the owners of the Propeties receive the just compensation, if any, required by N.J.S.A. App. A:9-51.7 and/or any other applicable law, the Municipality will proceed under the negotiation and valuation provisions of the Eminent Domain Act of 1971, N.J.S.A. 20:3-1 *et seq.* to value the impact of the flood hazard risk reduction measures on the affected property owners; and
- 10. In accordance with Executive Order No. 140, the Municipality will cooperate with the Office of Flood Hazard Risk Reduction Measures within the DEP for any negotiation or valuation proceedings under the Eminent Domain Act of 1971, N.J.S.A. 20:3-1 *et seq.*, and will make that Office a party to any legal proceedings instituted in connection with the Municipality's efforts to obtain the real property interests contemplated by this Resolution.

All persons employed by the Borough of Ship Bottom shall be paid compensation for that employment as may from time to time be fixed by Resolution of the Governing Body of the Borough of Ship Bottom, provided that such compensation shall be within the scale of limits set forth below in Section II.

The various employees and personnel of the Borough of Ship Bottom shall be paid salary scales and hourly rates within the framework established below:

This Ordinance shall provide the sole means of establishing the range of compensation for all regular Borough employees. Nothing contained herein, however, shall prevent the Borough of Ship Bottom from contracting for special professional services which shall be paid for by voucher.

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Council President English called for the correspondence from the Association of Surf Angling Clubs, requesting use of the beach for a fishing tournament. On a motion by Councilman Tallon, seconded by Councilman Rossi, the 100th Anniversary Fishing Tournament was approved for October 24 & 25, 2015. The tournament will cap the participation at 75 teams of 6 persons, with a maximum of 3 4X4 vehicles per team. The Borough will also waive the beach buggy permit fee for the 2 days of the tournament.

Roll Call: Tallon, English, Sinopoli, Gleason, Rossi and Hartman, all aye.

Council President English called for the request from Michael Cartwright and Christine Lotze to use the 27th St. beach on October 18, 2014 at 4:30 pm for their wedding ceremony. They expect 15 guests. On a motion by Councilman Rossi, seconded by Councilman Tallon, this request was approved.

Roll Call: Tallon, English, Sinopoli, Gleason, Rossi and Hartman, all aye.

Council President English called for Reports of Committees:

Revenue and Finance: Councilman David Hartman

Currently the tax office is preparing for the yearly tax sale. This is for the prior year of delinquent taxes and water and sewer. We will advertise for 4 weeks starting the week of the 13th in the Beach Haven Times or the Atlantic City Press. All delinquent payments need to be in by October 10th, at the latest, in order to avoid being part of the tax sale. Final notices went out several weeks ago, with delinquent amounts due. This is the only notice you will receive. Make every effort to pay this amount. Contact the tax office at extension 102 for any questions you may have regarding the sale. Water and sewer bills are due October 1st for flat rates and September 24th for the metered properties. Early October meter readings will be done again for the 3rd quarter ending September. All new metered properties with inspections done will be read starting the first quarter of 2015.

Taxes collected so far in September were \$182,655.35. \$9,430.00 of that were towards 2015, \$136,525.00 for 2014, \$29,797.00 for 2013 and \$6,892.00 for interest. Miscellaneous revenue was \$38,920.00, notables within that, \$3,025.00 was for tower rental, \$2,840.00 was for the boat ramp, \$200.00 was for beach buggy permits and \$74.16 was for copies of documents.

Public Safety: Councilman Tom Tallon

The public safety report for September 2014:

There were 491 reported activities. There were 5,843 patrol vehicle miles. There were 7 noise violations. There were 58 building and business checks. There were also 146 traffic stops, 2 motor vehicle accidents with injuries, 16 motor vehicle accidents without injuries and 1 DWI.

Today, Chief Sharkey informed me that The Ship Bottom PD is in receipt of twenty two thousand dollars from the Drug Enforcement Agency. This award stems from a joint drug investigation in 2011 that resulted in convictions and a significant seizure of assets. Previously the DEA acknowledged the Ship Bottom PD's contribution to the investigation in a letter I read at another council meeting.

Parks and Recreation: Councilman Edward English

The total boat ramp fees from January 1st to September 23rd is \$31,360.00. The beach revenue was \$624,462.00. The expenses for the beaches for this year was \$795,916.81. The difference is what the taxpayer needs to pick up.

7th, 15th, & 19th Street beaches have been guarded since September 2 and lifeguards will remain on duty up to and including September 30. These off-season lifeguards have performed countless preventative actions, assists, rescues, and first aids while patrolling and protecting the beaches. This post-season service is truly of great value to the local community and visitors alike and it has saved lives.

Water and Sewer: Councilman Richard Sinopoli

For the month of August, we pumped 19,295,000 gallons of water. The department inspected and operated plants and wells, helped with water meter reads and repairs, made all repairs to water & sewer systems as needed.

Public Property and Community Affairs: Dr. Robert Gleason

Construction Department: 41 permits and 7 permit updates issued. The type of work was 33 alteration/renovations, 1 reconstruction, 4 new buildings and 3 demolitions. The total revenue was \$15,227.00.

Zoning Department: 23 zoning permits issued and 2 resale inspections.

Code Enforcement: There were 20 verbal warnings: 3 unleashed dogs, 2 illegal signs, 5 trash, 2 trailers on street, 6 overgrown grass and 2 construction materials on street. 3 summons issued for trash.

The hazardous waste disposal program at the boat ramp went well. Total cardboard is 69,580 pounds. Our single stream total on the beach was 30,800 pounds. One raccoon was trapped. The fireman's fund raiser car show will be held on September 27th at the Waterfront Park. Dune grass planting will be on October 11th.

Buildings and grounds, improvements are ongoing.

Public Works: Councilman Peter Rossi

- 1. monthly maintenance and repairs done on all borough vehicles and equipment.
- 2. metal and brush picked up.
- 3. grass cutting, trimming, weeding and spraying, planted mums at the plaza.
- 4. assisted code enforcement with cardboard at 3rd Street yard.

- 11. assembled six memory benches and placed them throughout the borough.
- 12. moved desk and files for new administer and CFO.
- 13. repaired flag pole and replaced flag at the life guard headquarters.
- 14. filled pot holes through the borough and had Mr. Little, water dept. and public works check problem on 15th St., resident complained about drain clogged at the end of 15th St. and Barnegat Ave. Ocean County cleaned the drain. The problem is possible with residents' property sprinkler system.
- 15. removed graffiti from trash cans and poles under bridge, picked up life guard stands thrown in water, one in Surf City, another on 7th St..
- 16. began work and inspections on the violations at thewater treatment plant and 15th St. water building
- 17. We did 30 hours of mark outs

On a motion by Councilman Sinopoli, seconded by Councilman Rossi, and an all in favor vote, all aye, Council President English opened the meeting to the public.
