# Regular Meeting Minutes March 28, 2017

The following are the minutes of the Regular Meeting of the Mayor and Council of the Borough of Ship Bottom, which was held on Tuesday, March 28, 2017, in the Borough Hall Council Chambers, located at 1621 Long Beach Boulevard, Ship Bottom, New Jersey.

Mayor Huelsenbeck called the Caucus Meeting to order at 6:32 p.m.

Mayor Huelsenbeck asked the Clerk to take attendance. The following were present:

Mark Pino, Administrator and Kathleen Flanagan, Chief Finance Officer were present.

Caucus Meeting:

1. Linda Feaster from the Ocean County Library talked about their new digital sign and stated that the LBI branch was the first in the county system to have this type of sign. It was a gift from the "Friends of the Island Library". Mrs. Feaster gave a presentation about the need for libraries and how the federal budget cuts could affect the library system here.

2. Councilman Butkus talked about the water projects. Frank Little said that we could do the water meters while Long Beach Township is doing their water plant and when Long Beach Township is done, we could proceed with our water plant project. Between Councilman Butkus and Kathleen Flanagan, it was explained how we could get the water meters installed by the end of the year.

**SECTION 1.** Subsection 13.04.030(B) of Chapter 13.04 of the Borough Code of the Borough of Ship Bottom entitled "Rates, Fees and Charges" is hereby amended and supplemented to read as follows:

- B. Rates, Fees and Charges. The following rates, fees and charges shall be made and collected for the services and facilities of the comprehensive water system, commencing the service year of 2017:
  - 1. Flat fee for single dwelling unit, whether contained in singlefamily residence, duplex apartment, condominium, or other multifamily or project, three hundred (\$300.00);
  - 2. For each additional dwelling unit, whether contained in a duplex, apartment, condominium or other multifamily structure or project, three hundred dollars (\$300.00);
  - 3. All individual multifamily units serviced by a number of meters for the building, group of buildings or project in which the unit is located, less than the amount of the total of the units, shall be considered a metered unit and, in addition to the flat fees for each unit, the corresponding gallon usage charge, as set forth below, shall be pro-rated among such units;
  - 4. The quarterly minimum in gallons and minimum annual charge as set forth below for metered commercial establishments shall, in the case of a multifamily structure or project, be multiplied by the number of individual dwelling units contained in the multifamily structure or project;
  - 5. In addition to all the above pertaining to multifamily structure and project, all metered use attributable to the multifamily structure or project, without regard to form of ownership, and not attributable separately to each dwelling unit, shall be charged to the owner, occupant or association as the case may be, according to the commercial establishment schedule set forth below:
    - a. Swimming pool.....\$200.00
    - b. School.....\$400.00
    - c. Sprinkler system Lawn......\$200.00
  - 6. If a property contains more than one category in the above schedule, they will be billed for each such item;
  - 7. As of January 1, 1979, all commercial and nonresidential establishments shall be metered and the owner must bear the cost of meter, installation, and any and all repairs and maintenance of such meter or meters;
  - 8. Commercial property flat fee, three hundred seventy-five dollars (\$375.00);
  - 9. Gallonage Use. Gallonage use shall be charged at the rate of two dollars and sixty-eight cents (\$2.68) per thousand gallons.
  - 10. Notwithstanding any provision to the contrary, effective January 1, 2007, all new residential construction and major renovations to any structure, including residential dwelling units, shall install remote-read water service connection meters and meter pits, in accordance with the specifications adopted by the Borough Superintendent. No Certificate of Occupancy for any such new construction or renovation shall be issued until a certification of the installation of

the appropriate water meter is provided by the Borough Superintendent to the Construction Code Official. The owners of the above-described properties shall be billed for metered water usage in accordance with the following schedule:

There shall be a minimum fee of sixty two dollars fifty cents (\$62.50) per quarter for each residential dwelling. Thereafter, the following fees shall be calculated quarterly and billed annually:

0 - 14,000 @ \$1.00/thousand gallons

14,001 - 25,000 @ \$1.80/thousand gallons

25,001 - 50,000 @ \$3.70/thousand gallons

50,001 - 150,000 @ \$5.50/thousand gallons

150,001 – 300,000 @ \$8.10 thousand gallons

Over 300,000 @ \$9.50 thousand gallons

For the purpose of this subsection, major renovation shall mean any repair, reconstruction, rehabilitation addition, or other improvement of a structure, the cost of which equals or exceeds fifty percent (50%) of the assessed value of the structure either before the improvement is started or if the structure has been damaged and is being restored before the damage occurred. Substantial improvement is commenced when the first alteration of any structural part of the building is begun. Any newly installed irrigation systems will require the installation of a meter and meter pit.

11. All water service connection meters and equipment shall be obtained from a vendor with specifications provided by the water/sewer department.

Water connection reinspection fee: Fifty dollars (\$50.00).
SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid of unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

**SECTION 4.** This ordinance shall take effect after public reading and publication as required by law.

**SECTION 1.** Subsection 13.08.010(F) of Chapter 13.08 of the Borough Code of the Borough of Ship Bottom entitled "Rates, Fees and Charges" is hereby amended and supplemented to read as follows: F. Rates, Fees and Charges. The following rates, fees and

- Rates, Fees and Charges. The following rates, fees and charges shall be made and collected for the services and facilities of the comprehensive sewerage system commencing the service year 2017:
  - 1. Flat fee for single dwelling unit, whether contained in single-family residence, duplex, apartment, condominium or other multi-family structure or project, four hundred dollars (\$400.00).
  - 2. For each additional dwelling unit, whether contained in a duplex, apartment, condominium or other multi-family structure or project, four hundred dollars (\$400.00);
  - 3. All individual multifamily units serviced by a number of meters for the building, group of buildings or project in which the unit is located, less than the amount of the total of the units, shall be considered a metered unit and, in addition to the flat fees for each unit, the corresponding gallon usage charge, as set forth below, shall be pro-rated among such units;
  - 4. The quarterly minimum in gallons and minimum annual charge as set forth below for metered establishments shall, in the case of multifamily structure or project, be multiplied by the number of individual dwelling units contained in the multifamily structure or project;
  - 5. In addition to all the above pertaining to a multifamily structure and project, all metered use attributable to the multifamily structure or project, without regard to form of ownership, and not attributable separately to each dwelling unit, shall be charged to the owner, occupant or association as the case may be, according to the commercial establishment schedule set forth below;
  - 6. Commercial property flat fee: Four hundred dollars (\$400.00).
  - 7. School: Seven hundred fifteen dollars (\$715.00).
  - 8. Church: Four hundred dollars (\$400.00).
  - 9. Garbage disposal: Sixty-five dollars (\$65.00).
  - 10. Gallonage use over fourteen thousand (14,000) gallons quarterly shall be charged at the rate of two dollars and sixty-eight cents (\$2.68) per thousand (1,000) gallons.
  - 11. If a property contains more than one (1) category in the above schedule, they will be billed for each such category. When a property requires a disconnect from the sewer system, the owner and plumber shall be responsible for disconnecting the sewer and capping the sewer lateral. The water and sewer department will require forty-eight (48) hours notice prior to installation in order to schedule an inspection. An inspection fee of fifty dollars (\$50.00) will be required for each sewer service lateral.
  - 12. Inspection of disconnected sewer and cap: Fifty dollars \$50.00.
  - 13. Tappage fee: the tappage fee for any connection to the sewer system in the borough, shall be as follows:
    - (a) The tapping fee for a single family residential unit shall be one thousand three hundred twenty-five dollars (\$1,325.00) and for a duplex it shall be one thousand three hundred twenty-five dollars (\$1,325.00) per unit.
    - (b) The tapping fee for multifamily residential and non-residential shall be one thousand three hundred twenty-five dollars (\$1,325.00) per equivalent dwelling unit (EDU). Sewer connection fees shall be based on projected sewer consumption of the property with each equivalent dwelling unit (EDU) comprising of 60,000 gallons

of annual sewer consumption. The calculation of the connection fees for multifamily residential units and all nonresidential properties shall be determined by the borough engineer based upon the application and documentation provided by the applicant. Application and documentation shall include the projected sewer consumption date supplied by the applicant's engineer in accordance with the flow rates stipulated in NJAC 7:14A 23.3 Projected Flow Criteria in preparing the sewer application for approval by the governing body. It shall be within the discretion of the borough engineer to request additional documentation from the applicant as he/she deems appropriate.

(c) The amount of the connection fee shall be based upon an estimate as calculated in accordance with the borough's ordinances and, after receiving a recommendation from its borough engineer, the connection fee shall be paid before issuance of a certificate of occupancy.

14. Sewer connection reinspection fee: Fifty dollars (\$50.00).

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid of unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

**SECTION 4.** This ordinance shall take effect after public reading and publication as required by law.

Revenue and Finance: Councilman David Hartman

Good citizens of Ship Bottom, please make every effort to pay all delinquent tax and water sewer bills, this is very important for every homeowner in the borough. Linda and Dawn are working together on the tax sale which will be held May 24, 2017. This will be Linda's last tax sale and Dawns first. There are 52 properties on the current list to be sold for liens. Dawn has spent many hours contacting the owners on the list in an effort to help them avoid the sale. Tax revenue for March 2017 month the date is: \$260,131.60: Of that, \$197,795

was for 2017, \$56,310 worth for 2016 and \$6026 was for interest.

Public Safety: Councilman Tom Tallon

The public safety report for March 2017

There were 670 reported activities. There were 4,103 patrol vehicle miles. There were 222 beach, building and business checks. There were also 251 traffic stops, six motor vehicle accidents without injuries and two driving under the influence.

Parks and Recreation: Councilman Edward English

The 2017 beach badge order has been placed.

Seasonal beach badges will be available for sale on weekends at Borough Hall starting in May.

Swim test date for new and returning lifeguards is scheduled for Sunday, May 21 at 5 PM at the St. Francis Aquatic Center Pool.

Make-up swim test date is TBD.

Drug testing for returning lifeguards only is scheduled for June 3 from 9 AM to 12 PM, June 6 from 3 PM to 6 PM, June 8 from 3 PM to 6 PM, and June 10 from 9 AM to 12 PM at Beach Patrol Headquarters.

Beach Patrol personnel will start patrolling the beaches on weekends only beginning Memorial Day Weekend up to the first day of the season (Saturday before Father's Day).

Opening day this season is Saturday, June 17.

Public Property and Community Affairs: Councilman Joseph Valyo

Construction Department: 23 permits and 9 permit updates for a total of 32 permits. The type of work was: 21 alteration/renovations, 6 minor work, 4 addition/rehabs and 1 demolition. The total revenue was \$6,134.00. Zoning Department: There were 18 zoning permits and 12 resale inspections. We pumped 3,854,000 gallons of water for the month of February. We inspected & operated the plant and wells, helped with water meter reads and repairs and made all repairs to the water & sewer systems as needed.

For the month of March, collections of arrears were \$2,199.59, 2016 was \$6,849.35, Interest was \$314,43 for a total of \$9,363.37. The sewer payment total was \$11,407.59 with a combined total of \$20,770.96 for water and sewer.
