## RESOLUTION 2017-75 RESOLUTION OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, REQUESTING IMMEDIATE ACTION FROM THE OCEAN COUNTY FREEHOLDERS TO ADDRESS SEVERE FLOODING

**WHEREAS,** Flooding within the Municipalities of Beach Haven, Long Beach Township and Ship Bottom has become more frequent since Super Storm Sandy,

**WHEREAS,** Long Beach Blvd is the major evacuation route for residents and visitors to Long Beach Island,

**WHEREAS,** as a result of heavy rain events and storm events, the area of Long Beach Blvd in Ship Bottom from 23rd Street to 30th Street as well as the area of West 28th Street experiences severe flooding which makes Long Beach Blvd impassible.

**WHEREAS,** one of the contributing factors to flooding in 28th Street at the intersection of Central Ave. is the natural shoreline at the end of Central Ave which allows water to permeate through the earth berm

**WHEREAS**, there are no parallel roads to permit residents to bypass this area of Long Beach Blvd, 28th Street and Central Ave which creates a bottleneck in the evacuation route

- 1. Construct a bulkhead/retaining wall to seal off the end of Central Ave at 28th Street thus eliminating the earth berm.
- 2. Install a stormwater pump station at the end of Central Ave at 28th street to provide relief from flooding of the 28th Street and the Long Beach Blvd area noted above.
  - 3. Elevate the crown of Long Beach Blvd in the area between 23rd St and 30th St.

Drug testing for returning lifeguards only is scheduled for June 3 from 9 AM to 12 PM, June 6 from 3 PM to 6 PM, June 8 from 3 PM to 6 PM, and June 10 from 9 AM to 12 PM at Beach Patrol Headquarters.

Beach Patrol personnel will start patrolling the beaches on weekends only beginning Memorial Day Weekend up to the first day of the season (Saturday before Father's Day). Opening day this season is Saturday, June 17.

All flat service bills were mailed out by April 5<sup>th</sup> with a due date of May 1, 2017 and October 1, 2017. Metered Properties were mailed out by March 31<sup>st</sup> for the 1<sup>st</sup> quarter and due on April 15<sup>th</sup>.

The monthly water/sewer revenue is #361,849.89 with \$334.51 for interest. Year to date is \$528,711.85 with \$2,410.70 in interest.

For the month of March, we pumped 4,664,000 gallons. The Department inspected and operated the water plant and wells, helped with water meter reads and made all necessary repairs.
