Mayor Huelsenbeck called for Resolution 2018-115: Stafford Township Cooperative Pricing System. On a motion by Councilman Butkus, seconded by Councilman Rossi, this was approved as follows:

WHEREAS, N.J.S.A 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and WHEREAS, the Township of Stafford, hereinafter referred to as the Lead Agency" has offered voluntary participation in a cooperative Pricing System for the purchase of goods and services;

- e. To implement and enforce the policies of the mayor and borough council with respect to the compiling and release of public information;
- f. To supervise and continually review the borough's insurance program;
- g. To assist the borough council in negotiating contracts for the borough as authorized by and subject to the approval of the borough council;
- h. To act as a liaison on behalf of the borough, in a matter of offerance or contract, with all utility companies serving any portion of the borough to be sure that such utilities are providing adequately for the needs of the residents of the borough;
- i. To assure that the provisions of all franchises, leases, permits and privileges granted by the borough are complied with;

- j. To have knowledge of all equipment and materials owned and used by the borough and to arrange for the disposal of all inadequate or obsolete materials when directed to do so by the borough council;
- k. To keep the borough council currently informed of all matters within his or her jurisdiction by such reports, verbally or in writing, as he or she deems advisable or as may be requested by the borough council, and to submit an annual written report of his or her work accomplished at the request of the borough council for the benefit of the public;
- 1. To perform such other duties as may be assigned to him or her from time to time by the mayor and /or borough council; and

The total tax for this period is \$1,734,028.10 with \$1,597,420.61 from 2018, \$134,378.67 from 2019, \$1,951.78 in interest and \$277.04 from 2017. The 2018/2019 tax bills were mailed out on 8-15-2018 and the tax rate went up .069%. The 2017 tax rate was .991% and the 2018 tax rate was 1.060%.

The 3rd quarter tax payments are due 9-14-18 without penalty. As of today we have 49 properties that are delinquent in taxes totaling approximately \$83,000.00 in lost revenue.

The summer concert series was a success. We will begin planning for the Christmas Parade the end of September.

Boat ramp fees for 2018 are \$32,395.00 compared to 2017 of \$30,130.00. We are up \$2,265.00.

Beach badge fees for 2018 are \$709,042.00 compared to 2017 fees of \$726,065.00. We are down \$17,023.00.

All beaches will remain open and guarded throughout Labor Day Weekend. 7th, 15th and 20th Street beaches will be guarded daily September 4-30 from 10:00 am until 5:00 pm.

Public Property and Community Affairs: Councilman Joseph Valyo

Construction: 23 permits and 6 permit updates, for a total of 29 permits processed. The type of work was 22 alteration/renovations, 3 addition/rehabs, 3 new buildings and 1 demolition. The total revenue was \$35,854.00.

Zoning: 7 resale inspections and 30 zoning permits issued.

Code Enforcement: Verbal warnings for the following: 11 unleashed dogs, 17 illegal signs, 19 for trash, 2 trailers on street, 1 overgrown grass and 2 construction materials on street. There were also 2 summons' for construction materials on street.
