There were 765 reported activities. There were 4819 patrol vehicle miles. There were 107 beach, building and business checks. There were also 350 traffic stops, eighteen motor vehicle accidents without injuries, four motor vehicle accidents with injuries and three DUI's.

Parks and Recreation: Councilman Edward English

7th, 15th, & 20th Street beaches have been guarded daily from 10 AM to 5 PM since September 4 and lifeguards will remain on duty up to and including September 30. These off-season lifeguards have performed countless preventative actions, assists, rescues, and first aids while protecting and patrolling the beaches.

Lifeguard HQ has been staffed as well and very busy answering questions about daily ocean conditions, advising beach goers on the safest place to swim, and assisting beach patrons with our Beach Wheels Program. Our beach chairs provide the handicapped and those needing assistance access to the beach. The people that borrow our beach chairs are extremely appreciative.

It has been an active season for tropical storms and hurricanes. The lifeguards on duty in the post-season have made a huge difference in keeping people safe, promoting beach safety, and have saved lives.

Thanks to all departments for supporting the Ship Bottom Beach Patrol and making this another safe and successful summer!

Beach badge fees for 2017; \$727,267.00, for 2018; 712,610.00, which means we were down \$14,657.00. The boat ramp fees for 2017; \$33,850.00, 2018; \$36,625.00, which means we were up \$2,775.00.

We have the 39th Annual Christmas Parade coming up.

Public Property & Community Affairs: Councilman Joseph Valyo

Long Beach Island Health Department: Monthly blood pressure screenings, adult and child vaccinations available and flu shots available.

There will be a Flu Clinic, Women's Health Night and Annual Harvest Hayride. Check the LBI Health website or a link from our website.

Code Enforcement: Verbal warnings were: 2 for unleashed dogs, 10 for illegal signs, 7 for trash, 2 for trailer on street, 2 for overgrown grass and 2 for construction materials on street. There were 10 written warnings for overgrown grass. Recycling total for the month of August, we finished 14th out of 33 municipalities. In 2017 recycling, we finished 12th out of 33 municipalities for the year. For Zoning: 7 resale inspections and 1 review. Under animal control there were 2 raccoons trapped.

Zoning: 8 resale inspections done and 17 zoning permits issued.

There will be a CRS outreach this Saturday at the Beach Haven Merchant Mart. Literature and brochures will be available to the public. The Borough gains CRS points for this outreach done by the Coordinator.

Atlantic City Press ran our Annual outreach ad for flood insurance for additional CRS points. This was a coordinated effort throughout the Island. Construction: 11 permits and 5 permit updates were done. The type of permits: 12 alteration/renovations, 2 addition/rehabs and 2 new buildings. The total revenue was \$18,780.00.

The Ship Bottom Fire Co. will hold an Open House on October 13th from 12-3 pm.
