## Regular Meeting Minutes November 1, 2017

The following are the minutes of the Regular Meeting of the Mayor and Council of the Borough of Ship Bottom, which was held on Wednesday, November 1, 2017, in the Borough Hall Council Chambers, located at 1621 Long Beach Boulevard, Ship Bottom, New Jersey.

Mayor Huelsenbeck called the Special Meeting to order at 9:05 a.m.

Mayor Huelsenbeck asked the Clerk to take attendance. The following were present:
