### Regular Meeting Minutes December 26, 2017

**WHEREAS**, representatives of the Township of Long Beach ("Township") and the Borough of Ship Bottom ("Borough") conferred regarding the possibility and terms of a Shared Services Agreement for tax collector services which resulted in the proposed Shared Services Agreement attached as Exhibit A to this Resolution, the terms of which are incorporated herein by reference; and

**WHEREAS**, the Township's Governing Body held a public hearing on December 18, 2017, in connection with the proposed agreement. Among other things, at that time, the public was provided the opportunity to comment or object concerning the content or effect of the proposed agreement in accordance with N.J.S.A. 40A:65-1, et seq.; and

**WHEREAS**, pursuant to N.J.S.A. § 40A:65-11(d), the Borough, a non-civil service jurisdiction, shall provide tax collector services to the Township through the Borough's Tax Collector.

**NOW, THEREFORE, BE IT RESOLVED** that the governing body of the Borough of Ship Bottom approve and authorize the Mayor to execute the Shared Services Agreement attached as Exhibit A. Upon execution by the Borough of Ship Bottom, the Borough's administration shall take all reasonably necessary steps to implement and administer the terms of the shared services agreement.

Re: Annual Visitation for the Municipal Court

A representative from the vicinage Municipal Division is required to meet annually with representatives from each Municipal Court to conduct a thorough review of the court's administrative procedures and office practices. This meeting, known as a visitation, takes two business days to conduct and results in the completion and submission of the Municipal Court Visitation Report.

There are six major areas of court practices and procedures that are reviewed during the visitation.

Section I identifies general information about the court, including staffing levels and possible staffing deficiencies. This section focuses on the court's hours of operation, maintenance of reference materials and equipment used by the court. A review of the court facilities and conformity to State minimum standards as well as issues involving physical access to court areas are also part of this section.

Section II encompasses several administrative areas within the court. Information about the annual municipal court's budget and municipality's financial audit report are gathered. The status of any recommendations made in previous visitation reports is also noted. Funds and programs under the purview of the municipal court are detailed. Public access to court records and proceedings are included in this section as well. Section III focuses on the practices and procedures followed by the court with regard to case management. A large sampling of cases is examined, giving specific attention to filing, docketing and bail processing. Complaints and tickets that have been deleted, voided or dismissed are also examined. Vital court functions performed such as ticket control, assignment of public defenders, sound recordings and filings of municipal court appeals are reviewed. As part of case management, maintenance and destruction of records is noted.

Section IV centers around the proper collection, disbursement and general handling of monies collected by the court. Specifically, this section focuses on the court's procedures with regard to daily financial practices, monthly disbursements, bank reconciliations and installment payments.

Section V reviews the court's ability to manage and dispose cases in an effective manner. Special attention is given to identifying existing backlog.

The purpose of Section VI is to examine security measures in all areas of the court including implementation of a court security plan. The Municipal Court Schedule of Protection is reviewed in addition to security within the courtroom, the court offices and the violations bureau. This section also examines security measures taken when prisoners are present for court sessions.

The visitation report, once completed, is emailed along with a summary cover letter to the Municipal Court Judge, with a copy going to the Assignment Judge, Trial Court Administrator and the Municipal Court Administrator/Director. In the cover letter, the judge is asked to review the visitation report with staff and provide the Municipal Division with a written response, as appropriate, to the comments and recommendations offered in the report. Annually, at the end of each court year, the vicinage Municipal Division will submit a summary report of the municipalities visited during that court year to the Assistant Director of Municipal Court Services. Finally, the visitation report is designed to serve as a tool to help identify not only areas of concern but, equally important, areas where the court excels. This information is administratively beneficial to court staff in the development of its operational goals and practices.

I am pleased to announce that this year Ship Bottom's visitation went exceedingly well. There were no areas of concern nor was any follow up required. As stated by Lia C. Grasso, AS3 from the Administrative Office of the Courts "Karen and her staff work hard to maintain their level of excellence every day. They are dedicated to their assigned tasks and complete them effortlessly and timely. The files are organized and kept that way from the time they receive the case to its completion. . . This office works in an efficient and professional manner at all times."

Upon receiving the official visitation report, the Honorable James A. Ligouri JMC responded "Excellent job, thank you for your great efforts."
