Regular Meeting Minutes August 27, 2019

Boat ramp fees are up to \$40,530. from \$32,540. for 2018, an increase of \$7,990. Beach badge sales for 2018- \$709,467.00 and for 2019- \$927,870, which is an increase of \$218,403.00. Credit card sales accounted for \$126,660.00.

Public Property & Community Affairs: Councilman Joseph Valyo Construction: There were 20 permits and 9 permit updates, for a total of 29 permits processed. The type of work was 20 alteration/renovations, 4 addition/rehabs, 1 new

building, 2 additions and 2 demolitions. The total revenue was \$9,090.00. Zoning: there were 14 resale inspections and 14 zoning permits issued. For the month of July, we pumped 21,465,000 gallons of water.

We received \$19,193.29 in water payments and \$24,858.84 in sewer payments for a total of \$45,347.12 including \$120.02 in interest.

Once we have final approval from the Environmental Trust for the water meters, installation will begin.

Once we get the Clean Drinking Water Permit issued by NJDEP, we will start the water plant.
