Borough of Ship Bottom Regular Meeting Minutes January 28, 2014

The following are the minutes of the regular meeting of the Mayor and Council of the Borough of Ship Bottom, which was held on Tuesday, January 28, 2014, in the Municipal Building Council Room, located at 1621 Long Beach Blvd., Ship Bottom, NJ.

Mayor Huelsenbeck called the Caucus Meeting to order at 6:30 p.m. and asked the Clerk to take attendance. The following were present:

Councilmen Hartman, Tallon, English, Sinopoli, Gleason and Rossi.

Mayor Huelsenbeck asked the Clerk to read the Statement of Notice. It is as follows:

The time, date and location of this meeting was advertised in the Beach Haven Times, Atlantic City Press and Asbury Park Press. It was also posted on the bulletin board in the MunicipalBuilding, in accordance with the Open Public Meetings Act.

During Caucus, there was discussion regarding the following:

- 1. Councilman Tallon talked about placing clothing bins in the borough, one in the back parking lot and the other in the parking lot of the Library. The company would pay us \$1,500.00 per unit, per year.
- 2. Councilman Tallon talked to Paul Shives at the last JIF meeting about a \$20,000.00 grant for Police Accreditation. Once he researched this, he found it would be too costly for us at this time.
- 3. Rich Bethea talked about the modification of the AT&T lease on the water tower
- 4. Mayor Huelsenbeck stated that Joe Valyo was able to get a \$3,000.00 non matching grant for Emergency Management.

Mayor Huelsenbeckopened the regular meeting at 7:00 p.m. and asked the Clerk to take attendance. The following were present:

Councilmen Hartman, Tallon, English, Sinopoli, Gleason and Rossi.

Mayor Huelsenbeckasked the Clerk to read the Statement of Notice. It is as follows:

The time, date and location of this meeting was advertised in the Beach Haven Times, Atlantic City Press and Asbury Park Press. It was also posted on the bulletin board in the MunicipalBuilding, in accordance with the Open Public Meetings Act.

Mayor Huelsenbeckcalled for the Flag Salute, followed by a Prayer.

Mayor Huelsenbeckasked for the approval of the minutes of the December 17, 2013 meeting. On a motion by Councilman Tallon, seconded by Councilman English, these were approved as presented.

Roll Call: Hartman, Tallon, English, Sinopoli, Gleason and Rossi, all aye.

Mayor Huelsenbeckasked for the approval of the minutes of the January 2, 2014reorganization meeting. On a motion by Councilman Tallon, seconded by Councilman English, these were approved as presented.

Roll Call: Hartman, Tallon, English, Sinopoli and Rossi, all aye. Gleason, abstained.

Mayor Huelsenbeck called for the first item of new business, Resolution 2014-23: Human Trafficking Awareness Day. On a motion by Councilman Sinopoli, seconded by Councilman Tallon, this was approved as follows:

RESOLUTION 2014-23 A RESOLUTION OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY,

DESIGNATING JANUARY 11 AS HUMAN TRAFFICKING AWARENESS DAY

WHEREAS, human trafficking is a borderless crimeagainst individuals that violates the most basic human rights and deprives victims of every shred of personal freedom; and

WHEREAS, human trafficking occurs when a person is recruited, harbored, obtained, or exported through force, fraud, or coercion for the purposes of sexual or labor exploitation, involuntary servitude, and other types of mental and physical abuse; and

WHEREAS, human traffickers target impoverished and marginalizedchildren, women and men, isolating them from society and supportive networks and exploiting them for personal and monetary gain; and

WHEREAS, human trafficking is the fastest growing criminal enterprise in the world today, and is tied with arms smuggling as the second largest international criminal industry, falling only behind the illicit drug trade; and

WHEREAS, the United Nations' International Labour Organization has estimated that at least 12.3 million adults and children worldwide are currently in forced labor, bonded labor, or forced prostitution; and it is estimated that more people are now harmed by Human Trafficking worldwide than have been at any other point in human history. Approximately 80% of the victims are women and girls, and 50% are younger than age 18; and

WHEREAS, many victims trafficked into the U.S. do not speak or understand English and are unable to communicate to seek rescue. Under U.S. law, any person under 18 involved in the commercial sex industry is considered a Human Trafficking victim; and victims include U.S. citizens and documented immigrants; and

WHEREAS we recognize that New Jersey is a prime location for Human Trafficking because it is a major national and international transportation corridor and a culturally diverse state; and

WHEREAS, human trafficking is modern-day slavery, a practice that is in direct opposition to the fundamental principles of liberty and human rights upon which our nation was founded; and

WHEREAS, on February 1, 1865, President Abraham Lincoln signed the 13th Amendment to the United States Constitution. Once ratified, it officially outlawed slavery and involuntary servitude except as punishment for a crime; and

WHEREAS, Although the federal government and the State of New Jersey have enacted laws to prosecute human traffickers and protect the victims of human trafficking, traffickers use techniques to keep their victims enslaved that severely limit self-reporting and that require broad public awareness of human trafficking issues for enforcement and prevention to occur; and

WHEREAS, the New Jersey State Constitution declares that all persons are by nature free and independent and have certain natural and unalienable rights; and

WHEREAS, the people and the State of New Jersey, regardless of political persuasion, creed, race, or national origin, stand together with the national and global community to protect the fundamental freedoms and rights of all persons, to fight the proliferation of human trafficking in all of its forms, and to assist survivors of modern day slavery; and

WHEREAS, the Borough of Ship Bottom stands committed to protecting human rights and individual freedom by eliminating human trafficking.

WHEREAS, the Borough of Ship Bottom is resolved to support the goals and ideals of observing a National Day of Human Trafficking Awareness on January 11 of each year and to support all efforts by individuals, businesses, organizations, and governing bodies to raise awareness of and opposition to Human Trafficking.

WHEREAS, the Mayor and Council commends the work of the NJ Coalition Against Human Trafficking, Benedictine Academy, for its statewide efforts to end human trafficking through education, advocacy, and assistance to survivors and to increase coordination and visibility of New Jersey's commitment to end human trafficking.

NOW, THEREFORE BE IT RESOLVED that the Mayor and Council of the Borough of Ship Bottom, do hereby proclaim January 11 of each year as: "Human Trafficking Awareness Day" in the Borough of Ship Bottom, and to raise awareness about the signs and consequences of human trafficking, to promote opposition to human trafficking in all of its forms, and to encourage support for the survivorsof human trafficking throughout the State of New Jersey and across the world to put an end to this criminal activity and restore freedom and dignity to its survivors.

WHEREAS, Senate Bill S297 has been introduced; and

WHEREAS, Senate Bill S297 permits municipalities to hire a private company to provide construction officials, subcode officials, and technical assistants; and

WHEREAS, the Borough of Ship Bottom is in support of legislation which will allow the Borough to hire a private company in order to reduce costs to the municipality.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Ship Bottom, that we are in support of Senate Bill S297 and any identical companion bill that is introduced to the Assembly.

WHEREAS, May 22 is National Maritime Day in the United States each year; and WHEREAS, This day reflects the gratitude that Americans have for the maritime industry and the benefits it brings to the country; and

WHEREAS, It also recognizes ships and seafarers who have held a special place in the nation's history; and

WHEREAS, National Maritime Day recognizes the benefits of the maritime industry; and

WHEREAS, May 22 is the date that the American steamship *Savannah* sailed from the United States to England, which was the first successful crossing of the Atlantic Ocean using steam propulsion; and

WHEREAS, on May 20, 1933, Congress declared May 22 as National Maritime Day; and

WHEREAS, During World War II more than 250,000 members of the American Merchant Marine served their country, with more than 6700 giving their lives, hundreds being detained as prisoners of war and more that 800 ships being sunk or damaged.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Borough Council of the Borough of Ship Bottom that we recognize May 22nd as "National Maritime Day".

Mayor Huelsenbeck called for Resolution 2014-27: Authorizing interlocal, dispatching services. On a motion by Councilman Tallon, seconded by Councilman Rossi, this was approved as follows:

RESOLUTION 2014-27 A RESOLUTION OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF AN INTERLOCAL AGREEMENT WITH THE TOWNSHIP OF LONG BEACH IN ACCORDANCE WITH N.J.S.A. 40:8A-1 ET.SEQ. FOR DISPATCHING SERVICES TO BE PROVIDED BY THE TOWNSHIP OF LONG BEACH.

WHEREAS, the Interlocal Services Act, N.J.S.A. 40:8A-1, et. seq. authorizes two or more municipalities to enter into a mutual service agreement for the provision of certain governmental services; and

WHEREAS, Section 4 of P.L. 1973, c.208(C.40:8A-4) has been amended and approved as Chapter 356, on January 5, 1996 to authorize that such agreements can be adopted by Resolution; and

WHEREAS, it is deemed to be in the public interest of the residents and taxpayers of the Borough of Ship Bottom to authorize the renewal and continuation of such agreement for police dispatching services; and

WHEREAS, it is the desire of the Governing Body of the Borough of Ship Bottom to authorize the execution of a renewal agreement with the Township of Long Beach for police dispatching services in accordance with the terms set forth in the said Agreement; and

WHEREAS, the Borough has requested that the Township furnish to the Borough general police dispatching services, NCIC Look-Up Services, name and address property look-up services and 911 emergency dispatching services in accordance with the provisions of the last contract; and

WHEREAS, the Township of Long Beach has agreed to provide said police dispatching services to the Borough of Ship Bottom between February 15, 2014 and ending December 31, 2017 at the following rates for the term of the contract:

WHEREAS, the Township of Long Beach has provided adequate assurances of system comparability, compatibility, reliability and efficiency.

WHEREAS, the Ocean County Matching Tourism Promotional Grant Program has announced that funding is available to qualifying nonprofit organizations to promote tourism in Ocean County; and

WHEREAS, matching fund grants are available for 2014; and

WHEREAS, the Tourism Promotional Grant is to be used for promotion only.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Ship Bottom, County of Ocean, that the Chairman of Parks and Recreation is hereby authorized to apply to the Ocean County Matching Tourism Promotional Grant Program for a matching grant in the amount of \$1,500.00 to be used to promote and publicize Special Events.

WHEREAS, from time to time the Tax Assessor discovers an error in calculation, transposing, measurement, or typographical error in the tax assessments on the tax list after the time the County Board of Taxation has certified the tax rates for the tax year or a property becomes subject to a roll-back assessment; and

WHEREAS, the Governing Body of the Taxing District of the Borough of Ship Bottom is desirous that every taxpayer pays his fair share of taxes; and

WHEREAS, if the above discovered errors are not corrected, the taxpayers affected would not be paying their fair share of taxes; and

WHEREAS, the method for correcting such errors is to file a Petition of Correction of Errors with the Ocean County Board of Taxation.

WHEREAS, it is the desire of the governing body to authorize the execution of a Shared Services agreement with OceanCounty for animal facility services.

WHEREAS, a key element of the reforms, capping arbitration awards on economic factors to no more than 2% of the property tax levy will expire on April 1, 2014; and

WHEREAS, while municipalities are statutorily limited to raise their property tax levy by no more than 2%, with very limited exceptions, failure to extend the 2% cap on interest arbitration awards will force municipalities throughout the State to further reduce or even eliminate crucial services,

personnel, and long-overdue infrastructure improvement projects in order to fund an arbitration award; and

WHEREAS, the 2% Interest Arbitration cap has controlled one of the largest municipal expense, public safety salaries, not only through arbitration awards but through contract negotiations; and

WHEREAS, absent further action by the Legislature, any contract that expires on or after April 1, 2014, will be subject to all new procedures and requirements, EXCEPT the 2% awards cap; and

WHEREAS, without those limits, arbitrators will be able to impose awards that do not account for the 2% limit on the property tax levy, which would immediately threaten funding for all other municipal services; and

WHEREAS, without the 2% cap on Interest Arbitration Awards but with the 2% cap on property tax levy local budget makers could be forced to reduce other essential municipal services to fund an arbitration award.
