Borough of Ship Bottom Special Meeting Minutes May 2, 2014

The following are the minutes of the special meeting of the Mayor and Council of the Borough of Ship Bottom, which was held on Friday, May 2, 2014, in the Municipal Building Council Room, located at 1621 Long Beach Blvd., Ship Bottom, N.J.

Mayor Huelsenbeck called the Special Meeting to order at 9:00 a.m. and asked the Clerk to take attendance. The following were present:

Councilmen Hartman, Tallon, English and Sinopoli. Councilman Rossi and Dr. Gleason, absent.

Mayor Huelsenbeck asked the Clerk to read the Statement of Notice. It is as follows:

Mayor Huelsenbeck called for resolution 2014-86: Request to NJDOT, Rt. 72 West and Barnegat Ave.. On a motion by Councilman Sinopoli, seconded by Councilman English, this was approved as follows:

RESOLUTION 2014-86 RESOLUTION OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, REQUESTING NJDOT TO REEVALUATE THE INTERSECTION OF ROUTE 72 WEST AND BARNEGAT AVEUE

WHEREAS, at the intersection of Route 72 West and Barnegat Ave., there have been eight (8) motor vehicle accidents with injuries since January of 2014; and

WHEREAS, Police Chief Sharkey is requesting the Mayor and Council to compel New Jersey Department of Transportation to conduct a full evaluation of this intersection to determine the improvements needed in order to provide a safe and efficient roadway; and

WHEREAS, this request has been forwarded to the NJDOT previously without resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Ship Bottom, that we hereby compel the New Jersey Department of Transportation to conduct a full evaluation of the intersection at Route 72 West and Barnegat Ave. and make all needed adjustments and/or repairs as soon as possible.

BE IT FURTHER RESOLVED that a copy of this resolution be sent to NJDOT Commissioner James S. Simpson, Senator Connors, Assemblyman Rumpf, Assemblywoman Gove and Denise Peck at NJDOT Community Relations.
