Regular Meeting Minutes September 22, 2015

The following are the minutes of the Regular Meeting of the Mayor and Council of the Borough of Ship Bottom, which was held on Tuesday, September 22, 2015, in the Borough Hall Council Chambers, located at 1621 Long Beach Boulevard, Ship Bottom, New Jersey.

Mayor Huelsenbeck called the Caucus Meeting to order at 6:40 p.m.

Mayor Huelsenbeck asked the Clerk to take attendance. The following were present:

Councilmen Sinopoli, Rossi, Hartman, Tallonand English.Dr. Gleason, absent.

Mayor Huelsenbeck asked the Clerk to read the Statement of Notice. It is as follows:

The time, date and location of this meeting was advertised in the Beach Haven Times, Atlantic City Press and Asbury Park Press. It was also posted on the bulletin board in the Municipal Building, in accordance with the Open Public Meetings Act.

During the Caucus Meeting the following items were discussed:

- 1. Mary Ann Gutchigian discussed the request from the International Kite Festival for an additional location of 11th 16th Streets on the beach and the use of the Waterfront Park for a Craft Fair.
- 2. The League of Municipalities Convention in Atlantic City in November and who would like to attend.
- 3. Councilman Tallon and Councilman Hartman had suggestions to address the 27th& 28th St. flooding issue.
 - a. Raise the bulkhead on 28th St. and the bay
 - b. Ocean County to raise the riprap or install bulkhead at 28th St. and Central Ave.
 - c. Flapper valve to be replaced on 27th St., this has been ordered
- 4. Mooring of boats, there are problems on a couple of street ends: 20th St. & E. Bay Terrace, 19th St. & W. Bay Terrace.
- Diane Lorello, 247 W. 19th St., talked about the issues at 20th St. & E. Bay Terrace
- 5. The 5th St. property that the Borough owns on the corner of the bay and lagoon. There is an adjoining property owner(s) interested in purchasing this property.
- 6. Kathleen Flanagan talked about the Best Practices Checklist. We have a 0% loss in State Aid because we scored 41 points.

Mayor Huelsenbeck called for the approval of the minutes of the regular meeting held on August 25, 2015. On a motion by Councilman Tallon, seconded by Councilman English, the minutes were approved.

Mayor Huelsenbeck called for the Resolution 2015-145: Authorizing receipt of bids, water tower lease, carried from the August 25, 2015 meeting. On a motion by Councilman Hartman, seconded by Councilman Tallon, this was approved as follows:

RESOLUTION 2015-145 RESOLUTION OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE RECEIPT OF BIDS FOR THE LEASE OF MUNICIPAL PROPERTY FOR THE CONSTRUCTION OF A COMMUNICATIONS SHELTER AND OPERATION OF WIRELESS ANTENNAS

WHEREAS, it is necessary for the Borough of Ship Bottom to advertise for the receipt of bids for the lease of municipal property for the construction of a communications shelter and operation of wireless antennas; and

WHEREAS, the governing body has determined that a portion of the property, as set forth on Exhibit "A" attached hereto and made a part hereof, is not needed for public use; and

WHEREAS, it is the desire of the governing body to advertise for the receipt of bids for the lease of municipal property for the construction of a communications shelter and operation of wireless antennas.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

- 1. That the governing body does hereby authorize the receipt of bids for the lease of municipal property as set forth on Exhibit "A" for the construction of a communications shelter and operation of wireless antennas. The Municipal Clerk shall determine the time, date and place for the receipt of bids.
- 2. That the minimum bid price shall be \$48,000.00 per year for a minimum bid total of \$240,000.00 for the five-year lease period.
- 3. That the governing body reserves the right to reject any and all bids on said property.
- 4. That the use of the property shall be limited to the construction and maintenance of a communications shelter and operation of wireless antennas. Said premises shall not be used for any other purpose or purposes.
- 5. That a notice to bidder shall be published in regard to the receipt of bids as set forth herein, in accordance with the specifications prepared by the Borough of Ship Bottom.
- 6. That the advertisement of the method of bidding shall be published in a newspaper circulating in the municipality in which the leasehold is situated by two (2) insertions at least once a week during two (2) consecutive weeks; the last publication not be earlier than seven (7) days prior to the letting of the lease.
- 7. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Chief Financial Officer of the Borough of Ship Bottom.

Revenue and Finance: Councilman David Hartman

We had a note sale last week. Our tax exempt \$1.3 million bond sold to PNC Bank for .7399%. Our taxable \$1 million bond sold to Oppenheimer for 1.875%.

The tax sale is scheduled for October 8th at 10:30 AM in Council Chambers. When we first ran a lien list there were 66 properties to be sold at tax sale. As of today, the balance is 24. Although this has gone to advertising, there is still time to be removed from the final list of properties. Please make every effort to pay all delinquent amounts plus advertising costs. This must be in the form of cash, certified check or money order, to be accepted.

Regarding lien buyers-

Interest has been high in coming to the sale. Preregistration is not necessary, but we do appreciate when those planning to attend let us know in advance.

Tax revenue for September, month to date was \$230,774.15. Of that: \$170,202.00 was for 2015; \$30,398.00 was for 2014; \$20,758.00 was for 2016; \$9,414.00 was for interest on late payments.

Miscellaneous revenue for September, month-to-date was \$35,081.63. Notables within that were: municipal court fines and costs for \$30,191.00; tower lease rental for \$3,025.00; beach buggy licenses for \$325.00; and garage sale fees for \$20.00.

Public Safety: Councilman Tom Tallon

The public safety report for September 2015

There were 786 reported activities. There were 146 building and business checks. There were 4,780 patrol miles. There were also 300 traffic stops, 2 motor vehicle accidents with injuries, 15 motor vehicle accidents without injuries and 2 DWI's.

Parks and Recreation: Councilman Edward English

7th, 15th, & 20th Street beaches have been guarded since September 7 and lifeguards

will remain on duty up to and including September 30. We've been getting a lot of positive comments from those that are using the beach.

Water/Sewer: Councilman Richard Sinopoli

For the month of August, we pumped 24,909,000 gallons of water. We inspected & operated the plant and wells, including making all repairs to the system as needed. We helped with water meter reads and repairs.

Public Property and Community Affairs: Councilman Sinopoli for Dr. Gleason (absent) Zoning Department: There were 19 zoning permits and 2 resale inspections. Construction Department: There were 13 permits and 9 permit updates issued. The type of work was 23 alteration/renovations, 2 renovation/reconstruction, 3 minor work, 9 addition/rehabs, 3 new buildings and 2 demolitions. The total revenue was \$25,107.00.

Code Enforcement: There were 27 verbal warnings: 4 unleashed dogs, 12 illegal signs, 5 trash, 3 trailer on street, 3 construction materials on street. There were 4 written warnings for overgrown grass and 1 summons for construction materials on street. The fireman are holding their car show as a fundraiser on Saturday. There will be cars, food, beer, wine and a live band.
